GENERAL DESCRIPTION

Performs complex veterinary work involving specialized professional diagnostic and prognostic evaluation of conditions of racing animals. Oversee all matters regarding animal health, welfare and husbandry practices on the grounds of the racetrack and report irregularities to the Board of Stewards. Works under limited supervision with considerable latitude for the use of initiative and independent judgment.

ESSENTIAL JOB FUNCTIONS

- Make soundness determinations for horses injured, ill or lame. Enter that data into Commission database along with recommendations for subsequent evaluations.
- When necessary, make recommendation for the removal of a horse from competition or, if necessary, humanely destroy the horse.
- Act as primary liaison between the Racing Commission and horsemen, practicing veterinarians, and all other direct horse care and service personnel on matters relating to the rules and policies governing animal health and welfare issues.
- Have general oversight of all test barn activities and personnel.
- Interface with other racing officials for all matters pertaining to horse care, communicable disease, livestock regulatory matters, and medication questions.
- Forward all workload data, incident reports, deviations from standard testing procedures, and policy inquiries to the Chief Veterinarian for action.
- Oversee practicing veterinarians and direct submission of essential samples and diagnostic procedures required by rules and policy.
- Primary headquarters is Retama Park; limited travel to other tracks as necessary.

MINIMUM EDUCATION AND EXPERIENCE:

- Graduate of a licensed accredited college of veterinary medicine.
- Meet licensing requirements as mandated by the Texas State Board of Veterinary Medical Examiners.
- Current licensure in good standing with the Drug Enforcement Agency (DEA).
- Current State and Federal Accreditation status desirable.
- At least five (5) years experience as a practicing (equine performance) or racetrack regulatory veterinarian.
- Experience in governmental/regulatory practice is beneficial but not required.

KNOWLEDGE, SKILLS, AND ABILITIES

- Demonstrated ability to evaluate race animals for soundness and health.
- Demonstrated oral and written communication skills
- Computer and keyboard proficiency
- Willingness to work in barn and racetrack environment
- Willingness to work weekends and holidays
