- 319.3 DRUG POSITIVE OR PERMITTED MEDICATION VIOLATION
- 311.104 TRAINER/ABSOLUTE INSURER
- 319.302 REASONABLE OVERSIGHT OF ANIMAL

Owner-Trainer, Alejandro Villarreal, having been duly noticed waived his right to a formal hearing and right to appeal before the Gillespie County Fair Board of Stewards on 08/11/2014. Pursuant to an agreed settlement. Mr. Villarreal accepted a one-thousand (\$1000.00) dollar fine, a suspension of 30 days, (08/11/2014 thru 09/09/2014) and a purse redistribution. On 07/20/2014, Mr. Villarreal, raced the horse "EXECUTIVE GLIMPS" in the 3rd race at Gillespie County Fair. A post-race urine sample, labeled # GC008600 collected from the horse, "EXECUTIVE GLIMPS" was found to contain a Class 3 B prohibited substance, Clenbuterol, at a concentration of 365 +/- 23pg/ml.

During the term of this suspension, Mr. Alejandro Villarreal is denied access to all facilities under the jurisdiction of the Texas Racing Commission. Entry of any horse owned or trained by Mr. Villarreal is denied pending sale or transfer to a party approved by the Board of Stewards.

(2nd violation in this classification within the last 365 days.)

Prior to disposition of this initial race, the horse "EXECUTIVE GLIMPS" was scratched from the finals on 08/10/2014 in race 11 at Gillespie County Fair for which "EXECUTIVE GLIMPS" was ineligible. As a result, "EXECUTIVE GLIMPS" is hereby disqualified from both races and declared unplaced, with the purse to be redistributed in accordance with the following official order of finish:
