319.3 DRUG POSITIVE OR PERMITTED MEDICATION VIOLATION

Upon being duly notified, Owner/Trainer Michael Neatherlin waived hearing and was fined seven hundred fifty dollars and suspended fifteen days (05/17/10 through 05/31/10) by the Lone Star Park Board of Stewards for clenbuterol in the test samples from the following three horses: Ms Stormin' Yankee #LS029785, the winner of the tenth race on 04/16/10, Vow To Greatness #LS029806, the second place finisher in the tenth race on 04/17/10, and Dancing Away #LS029842, the second place finisher in the ninth race at Lone Star Park on 04/22/10. Ruling amended to include Dancing Away on 06/06/10 due to mitigating circumstances of these positives reported in same time period warranting a single penalty.

During the term of this suspension Mr. Neatherlin is denied access to all facilities under the jurisdiction of the TxRC. Horses owned or trained by Mike Neatherlin are denied entry pending sale or transfer to a party approved by the board of stewards.

The horses Ms Stormin' Yankee, Vow to Greatness, and Dancing Away are hereby disqualified and declared unplaced with the purses to be redistributed as follows:
