Upon being duly notified, Owner/Trainer Milo Brent Davidson appeared in a hearing before the Lone Star Park Board of Stewards on 10/08/2010. After consideration of the evidence and testimony presented, Brent Davidson is hereby fined one thousand five hundred dollars and suspended one hundred eighty days (10/18/10 thru 04/15/11) for fluphenazine in test sample #LS030672, collected from the horse Blue Grits, the winner of the third race at Lone Star Park on 07/08/2010.

During the term of this suspension Mr. Davidson is denied access to all facilities under the jurisdiction of the Texas Racing Commission. Entry of any horses owned or trained by Brent Davidson is denied pending sale or transfer to a party approved by the Board of Stewards.

The horse Blue Grits is hereby disqualified and declared unplaced in the third race on 07/08/2010 with the purse to be redistributed as follows:

Supplement # 1

10/15/2010

Appeal filed on October 13, 2010. A temporary stay has been granted until October 28, 2010, for the purpose of allowing Mr. Davidson to secure legal counsel.

Supplement # 2

10/28/2010

Davidson retained Tammy Wincott as his attorney, who requested an extension of the stay. By letter of 10/27/10, E.D. King granted an indefinite stay, pending the outcome of the appeal.

Supplement # 3

01/28/2011

Interim Executive Director Trout entered into a Settlement Agreement with Davidson on January 28, 2011. The terms of the agreement are: 90 day suspension, beginning February 2, 2011, through May 2, 2011; fine of \$5,500, including the \$1,500 already paid, so the remaining \$4,000 is due no later than May 2, 2011; "Blue Grits" ordered unplaced in the third race at Lone Star Park on July 8, 2010, and the purse redistributed accordingly, \$150 appeal bond to be refunded upon full payment of the fine.
