Owner-Trainer, Robert Wesley Hatch, having been duly noticed, waived his right to a formal hearing and his right to appeal before the Retama Park Board of Stewards on 10/20/2009 and pursuant to an agreed settlement, is hereby fined one-thousand (\$1000.00) dollars and a purse redistribution, as a result of two (2) positive tests, sample number RP028359 being returned on the horse "BIG STAR RISING", the first place finisher in Race 2, indicating the presence of Phenylbutazone overage concentration of 18.3 ug/ml and sample number RP028365 being returned on the horse "HOW'S THAT", the third place finisher in Race 4, indicating the presence of Phenylbutazone overage concentration of 14.2 ug/ml , both at Retama Park on 09/24/2009. The two offenses having occurred on the same day are considered as one violation.

(1st offense of 10 ug/ml or over within 12 months)

The horses "BIG STAR RISING" and "HOW'S THAT" are hereby placed on the veterinarian's list and must meet all requirements of the Texas Racing Commission Veterinarian prior to removal and subsequent entry.

The horse "BIG STAR RISING" is hereby disqualified, declared unplaced, and the purse is ordered redistributed in Race 2 on 09/24/2009, and the horse "HOW'S THAT" is hereby disqualified, declared unplaced, and the purse is ordered redistributed in Race 4 on 09/24/2009 in accordance with the following official order of finishes:
