Rules Violated:

- 319.3 DRUG POSITIVE OR PERMITTED MEDICATION VIOLATION
- 311.104 TRAINER/ABSOLUTE INSURER
- 319.302 REASONABLE OVERSIGHT OF ANIMAL

Owner-Trainer, Jorge Luis Muniz, having being duly notified, waived his right to a formal hearing and right to appeal before the Gillespie County Fair Board of Stewards on 08/24/2013. Pursuant to an agreed settlement, Mr. Muniz accepted a fine of five-hundred (\$500.00) dollars and a suspension of his Texas Racing Commission license(s) for fifteen (15) days beginning on 08/26/2013 through 09/09/2013, and a purse redistribution. On 07/27/2013, Owner-Trainer, Jorge Luis Muniz, raced the horse, "LITTLE MS TUFFY", the First place finisher in the 5th race at Retama Park. A post-race urine sample labeled RP 032015 collected from this horse was found to contain a Class 3B prohibited substance, Clenbuterol at 1047 +/- 78 pg/ml.

During the term of this suspension, Owner-Trainer, Jorge Luis Muniz, is denied access to all facilities under the jurisdiction of the Texas Racing Commission. Entry of any horse owned or trained by Mr. Muniz is denied, pending sale or transfer to a party approved by the Board of Stewards.

(1st violation in this classification within the past 365 day period.)

Prior to disposition of this initial race, the horse "LITTLE MS TUFFY", competed in the finals on 08/10/2013 in race 9 at Retama Park and placed 9th, a race for which "LITTLE MS TUFFY" was ineligible. As a result, "LITTLE MS TUFFY" is hereby disqualified from both races and declared unplaced, with the purse of each race to be redistributed in accordance with the following official order of finish:
