Owner - Trainer Isidro Flores was duly noticed and waived his right to a formal hearing before the Retama Park Board of Stewards and his right to appeal on 9/6/14.

Mr. Flores is hereby fined seven hundred and fifty (\$750) dollars and suspended for fifteen days (9/16/14 through 9/30/14) because a post race sample taken from his horse, "Stolin Wagon," that won the 6th race at Retama Park on 6/13/14, tested positive for Clenbuterol @ 180+/- 28 pg/ml, and for excess Phenylbutazone @ 2.7 +/- 0.1 mg/ml. (Sample #RP032646).

First violations within 365 days.

The horse, "Stolin Wagon," is hereby disqualified and declared unplaced in the 6th race, a trial race for the Sire's Cup Futurity at Retama Park on 6/13/14. The purse is ordered redistributed as follows:
