- 311.104 TRAINER/ABSOLUTE INSURER
- 319.3 DRUG POSITIVE OR PERMITTED MEDICATION VIOLATION
- 319.302 REASONABLE OVERSIGHT OF ANIMAL

Owner - Trainer Raul Galvan was duly noticed and waived his right to a formal hearing and his right to appeal before the Retama Park Board of Stewards on 9/7/15.

Mr. Galvan is hereby fined five hundred (\$500) dollars and suspended for 15 days (9/13/15 through 9/27/15) because a post race sample (RP041865) taken from his horse, "Volcoms Thunder," the winner of the 6th race at Retama Park on 7/24/15 tested positive for Clenbuterol, a Class 3B prohibited drug, @ 410 +/- 80 pg/ml. First violation within 365 days.

The horse, "Volcoms Thunder," is hereby disqualified and declared unplaced in the Adequan Derby Trial, the 6th race at Retama Park on 7/24/15, and the purse is ordered redistributed as follows:

1. (5) Stolin Wagon
2. (8) Marys Coronitas
3. (9) Time For Wine
4. (7) Grande Sin Tacha
5. (4) Jessica Valenti
6. (2) Chasin The Moon
7. (3) Paint Your Hips
8. (1) Jumpn On Glass

Unplaced: (6) Volcoms Thunder.

As "Volcoms Thunder" is unplaced in the trial race, he is also disqualified and declared unplaced in the Adequan Derby Finals, race 8 at Retama Park on 8/8/15, with the purse ordered redistributed as follows:

2. (6) Freakin Runaway
3. (2) Jumpn Streak
4. (1) Time For Wine
5. (4) Cyclone Vic
6. (3) Miss Fast Jeans
7. (9) Flier Dash
