Owner-Trainer Eusevio Huitron having been duly noticed, failed to appear at a formal hearing before the Sam Houston Race Park Board of Stewards on 06/24/2010. Mr. Huitron is hereby suspended fifteen (15) days and fined seven hundred and fifty (\$750) dollars in absentia, and the purse is ordered redistributed for a positive test for the drug Clenbuterol sample #SH046923 taken from his horse "Awe Contraire" winner of the 2nd race (John Deere Texas Juvenile Challenge Trial) at Sam Houston Race Park on 04/30/2010. As this race was a "Trial" it rendered "Awe Contraire" ineligible for the final (John Deere Texas Challenge Final) 8th race at Sam Houston Race Park on 05/15/2010 also won by "Awe Contraire." The purse for the 8th race at Sam Houston Race Park on 05/15/2010 is also ordered redistributed.

The horse "Awe Contraire" is hereby disqualified and declared unplaced from the 2nd race at Sam Houston Race Park on 04/30/2010 with the purse to be redistributed as follows:

The horse "Awe Contraire" is hereby disqualified and declared unplaced from the 8th race at Sam Houston Race Park on 05/15/2010 with the purse to be redistributed as follows:

4. (5) One N A Million
