Owner-Trainer Jorge Barrera having been duly noticed, waived his right telephonically, to a formal hearing before the Sam Houston Race Park Board of Stewards on 5/12/2012 and his right to appeal. Mr. Barrera is hereby suspended fifteen days (May 14th through May 28th 2012) and fined seven hundred and fifty (\$750) dollars for a positive test for Clenbuterol, sample number SH049813, taken from his horse "Country Flying Chic" winner of the 7th race, a 'Trial', at Sam Houston Race Park on 03/22/2012 and winner of the 8th race, the 'Final,' at Sam Houston Race Park on 4/07/2012.

During the term of his suspension Mr. Barrera is denied access to all facilities under the jurisdiction of the Texas Racing Commission.

Entry of any horse owned or trained by Mr. Barrera is denied pending transfer to a party approved by the Board of Stewards.

The horse "Country Flying Chic" is hereby disqualified from the 7th race (Trial) on 3/22/2012 and declared unplaced with the purse to be redistributed as follows:

 4. (8) Jess My Prize
 5. (4) Jeez
 6. (5) Runaway B
 7. (2) Kiss and Teller

The horse "Country Flying Chick" is also disqualified from the 8th race (Final) on 4/07/2012 and declared unplaced with the purse to be redistributed as follows:
