Trainer Katie Carlos, having been duly noticed, waived her right to a formal hearing before the Sam Houston Race Park Board of Stewards on 5/18/2012 and her right to appeal. Ms. Carlos is hereby suspended nine months (5/28/2012 through 2/27/2013) and fined two thousand five hundred (\$2500) dollars for positive tests for Nalbuphine (Class 2) and Clenbuterol (Class 4) sample # SH049814 taken from her horse "Latest Dive" second place finisher in the 7th race, a 'Trial', at Sam Houston Race Park on 3/22/2012.

During the term of her suspension Ms. Carlos is denied access to all areas under the jurisdiction of the Texas Racing Commission. Entry of any horse owned or trained by Ms. Carlos is denied pending transfer to a party approved by the Board of Stewards.

The horse "Latest Dive" is hereby disqualified from the 7th race at Sam Houston Race Park on 3/22/2012 and declared unplaced with the purse to be redistributed as follows:

  3. (8) Jess My Prize
  4. (4) Jeez
  5. (5) Runaway B
  6. (2) Kiss and Teller

The horse "Latest Dive" is also disqualified from the 8th race (Final) on 4/07/2012 and declared unplaced with the purse redistributed as follows:
