Owner-Trainer Inez C.DeLaCruz having been duly noticed, waived his right telephonically to a formal hearing before the Sam Houston Race Park Board of Stewards on 03/20/2013 and his right to appeal. Mr. DeLaCruz is hereby suspended 15 days (04/21/2013 through 05/05/2013) and fined five hundred (\$500) dollars and loss of purse for a positive test for Clenbuterol @ 0.474 ng/ml plus or minus 0.013, sample #SH051102, taken from his horse "Cassinni" 2nd place finisher in the 8th race at Sam Houston Race Park(The Sam Houston Maiden Classic Trial) on 03/28/2013.

The horse "Cassinni" is disqualified from 2nd place in the 8th race at Sam Houston Race Park on 03/28/2013 and the purse is redistributed as follows:

1. (8) A Chick Called Linda
 2. (5) King of Leon
 3. (1) Happy Fete
 4. (6) Dashin For Joker
 5. (3) Wicked Sizzle
 6. (4) Streakin Villian
 7. (2) Hardleon
- Unplaced (7) Cassinni.

The horse "Cassinni" is also disqualified from the 8th race at Sam Houston Race Park on 4/12/2013 (The Sam Houston Maiden Classic Final) and the purse is ordered redistributed as follows.

1. (4) Plunge The Depths
2. (2) Taste This Corona
3. (8) CJS Rocksolid
4. (1A)Tres Alley Cat
5. (1) Choice Cartel
6. (5) Body Of Evidence
