Owner-Trainer Juan Saucedo having been duly noticed waived his right to a formal hearing before the Sam Houston Race Park Board of Stewards on 04/26/2013 and his right to appeal. Mr. Saucedo is hereby suspended 15 days (05/5/2013 through 05/19/2013), and fined one thousand (\$1000) dollars for positive tests for Clenbuterol, taken from his horses "No Price to Pay" winner of the 6th race at SHRP on 04/05/2013 Sample #SHO51189 and "Streak N Away RR" winner of the 8th race at SHRP on 04/06/2013 Sample #SHO51213.

In mitigation, the horses ran on consecutive days and Mr. Saucedo did not have notice of the first positive prior to the running of the second horse.

(1st violation in this category in the past twelve months)

The horse "No Price to Pay" is hereby disqualified from 6th race at Sam Houston Race Park on 04/05/2013 with the purse money redistributed as follows:

 3. (5) RC Grimm
 4. (2) Thirds Blue Legend
 5. (1) Gold Mettle
- Unplaced: (6) No Price to Pay

The horse "Streak N Away RR" is hereby disqualified from 8th race at Sam Houston Race Park on 04/06/2013 with the purse money redistributed as follows:

1. (6) A Quick Royal
2. (5) A Landslide Bet
3. (1) The Queens Corona
