Owner - Trainer Javier Noel Contreras was duly noticed and failed to appear for a hearing before the Sam Houston Race Park Board of Stewards on 5/17/13.

Mr. Contreras is hereby fined one thousand (\$1000) dollars and suspended for 30 days (5/26/13 through 6/24/13) because a sample taken from his horse " De Future Corona," the second place finisher in the 6th race at Sam Houston Race Park on 3/29/13 contained Clenbuterol @ 0.200 ng/ml +/- 0.01 ng. Sample # (SH051119).

Second violation within 12 months.

The horse, "De Future Corona" is hereby disqualified from the 6th race at Sam Houston Race Park on 3/29/13, a trial race for the Sam Houston Derby, and the purse money shall be redistributed as follows:

- 1) #8 Flirtingwithamiracle
  - 2) #7 SS Poker Face Dream
  - 3) #9 RDD Dashin Effort
  - 4) #4 Laneview La Jolla
  - 5) #2 TH Dominator
  - 6) #10 Bobcat Moon

- Unplaced : # 3 De Future Corona

"De Future Corona" is also hereby disqualified from the finals of the Sam Houston Derby, Race 7 on 4/13/13, and the purse shall be redistributed as follows:

- 2) #4 CC Wants It All
- 3) #8 Mystical Cartel RR
