Owner - Trainer Don Poteet was duly noticed and waived his right to a formal hearing before the Sam Houston Race Park Board of Stewards and his right to appeal on 5/18/13.

Mr. Poteet is hereby fined five hundred (\$500) dollars and suspended for fifteen days (5/20/13 through 6/3/13) because a sample taken from his horse, "Runaway Corona," the winner of the 7th race at Sam Houston Race Park on 3/29/13 contained Clenbuterol @ 0.225 ng/ml +/- 0.01 ng. (Sample # SH051120). First violation within 12 months.

The horse, "Runaway Corona," is hereby disqualified from the 7th race at Sam Houston Race Park on 3/29/13, a trial race for the Sam Houston Derby, and the purse shall be redistributed as follows:

 - 3) #1 Grizzly Water
 - 4) #9 Rooms By The Hour
 - 5) #7 Daisies Paint
 - 6) #8 My Te Fast Cat

"Runaway Corona" is also hereby disqualified from the Sam Houston Derby, race 7 on 4/13/13 at Sam Houston Race Park, and the purse shall be redistributed as follows:
