Trainer Servando Camacho having been duly noticed, waived his right to a formal hearing before the Sam Houston Race Park Board of Stewards on 05/09/2014 and his right to appeal.

Mr. Camacho is hereby fined twenty five thousand (\$25,000) dollars and suspended 3 years (05/12/15 through 05/11/18) for a positive test for the Class 1 drug Mephentermine and the Class 2 drug Phentermine taken from his horses "Executive Rule" winner of the 15th race at Sam Houston Race Park on 03/29/2014, sample #SH054374, and "Executive Successor" winner of the 11th race at Sam Houston Race Park on 03/29/2014, sample #SH054366.

Second violation.

The horse "Executive Rule" is hereby declared unplaced from the 15th race at Sam Houston Race Park on 03/29/2014 and the purse is redistributed as follows:
