Owner - Trainer Barbara Alcantara was duly noticed and waived her right to a formal hearing before the Retama Park Board of Stewards and her right to appeal on 6/11/15. An informal hearing was held and the Board of Stewards considered the evidence and testimony presented.

Ms. Alcantara is hereby fined five thousand (\$5000) dollars and suspended for one year (June 15, 2015 through June 14, 2016) because a post race sample labeled #SH061737, taken from her horse, "Portenntum," that won the 5th race at Sam Houston Race Park on 4/3/15 tested positive for Zilpaterol, a Class 2A prohibited substance.  
First violation within 365 days.

During the term of this suspension, Ms. Alcantara is denied access to all areas under the jurisdiction of the Texas Racing Commission. Entry of horses owned or trained by Ms. Alcantara is denied pending transfer to a party approved by the Board of Stewards.

The horse, "Portenntum" is hereby disqualified from race 5 at Sam Houston Race Park on 4/3/15, a trial for the Sam Houston Derby, and declared unplaced. "Portenntum" is therefore ineligible for the finals, and declared unplaced in the finals, race 8 at Sam Houston Race Park on 4/25/15 with both purses redistributed in accordance with the following official orders of finish:
