

3	CHAIRMAN PATE: And now, please join and recite
4	the pledge of allegiance to the Texas flag.
5	(Whereupon, a pledge to the Texas flag was
6	recited.)
7	CHAIRMAN PATE: Please be seated. All right.
8	I welcome you all to the August meeting of the Texas
9	Racing Commission. As usual, there are a number of items
10	that deserve mention this morning that I am going to bring
11	to the attention of all the Commissioners.
12	Today's meeting will largely focus on several
13	items related to the continuity of business operations for
14	the horsemen's organizations and licensed racetracks.
15	There were two key decisions that the Legislature made
16	during the session this year that will affect the
17	operations of the Commission over the next two years.
18	First, although the Agency staff requested
19	contingency funding to regulate greyhound racing, should
20	that activity continue in this state, there was no funding
21	appropriated for the regulation of greyhound racing. In
22	effect, there can be no greyhound racing as there are no
23	funds to support the required regulation of any pari-
24	mutuel betting related to it.
25	Second, the Agency, beginning September 1,
	ON THE RECORD REPORTING (512) 450-0342

1 2023, will now be funded with 20 percent General Revenue, 2 which is a promising development in our efforts to create 3 sustainable and transparent governance practices at the 4 Agency. This will lessen the Agency dependence on track 5 fees, and we think improve and properly context the 6 relationship between the Agency as regulator and the 7 various regulated parties.

Also, many of you may not be aware. But before and early in the legislative session, there was great interest in the various racetrack license, and the ownership of those license as a result of proposed legislation which was tied to licensure to possible new investment opportunities and casino gambling in Texas.

14 Several legislators made specific inquiry of 15 the Racing Commission before the session on various 16 license ownerships as part of their legislative effort. 17 In an attempted response, the Texas Racing Commission staff discovered the poor condition of the Agency's 18 19 license records. It necessarily spurred our interest to 20 obtain answers to questions requested, which also ties into the racing and required review of all licenses. 21

22 Our focus this fall, then, is on several items, 23 including the review of the eight active and inactive 24 racetrack license, as required by our statute. Director 25 Cook and General Counsel Virginia Fields have been working

1 with our racetrack licensee representatives since last 2 fall to review the Agency records to determine whether all 3 documents that should be at the Agency for each license 4 are actually on file, ahead of the scheduled reviews.

5 And I don't think it is any secret, we are 6 missing some papers. And we're fixing that problem. In 7 each and every case, our primary concern will be that the 8 Commission has, with respect to each license, a designated 9 individual who will bear responsibility for assuring 10 compliance with the Texas Rules of Racing and can serve as a designated point of contact when the Racing Commission 11 through its veterinarians, stewards, or enforcement 12 13 personnel or management had an issue.

14 Beyond clarifying communications and 15 responsibility, we anticipate some technical issues may 16 arise, all of which we intend to resolve as such arise. 17 Accordingly, I have asked Director Cook to schedule these reviews in every case, first for discussion by the staff, 18 19 and licensed representatives provide the Commission necessary background, such as will be provided here today. 20 And then later, for decision, as appropriate. 21

It is critical for all of us as we rebuild the Agency that we have worked with our interested parties to gather all pertinent records for each licensed racetrack, so that the Commissioners can make informed decisions.

1 Today, we will hear from the staff and 2 representatives of Penn Entertainment and the Retama 3 organization about the two licenses scheduled for 4 discussion this month. In the last several weeks, the 5 Agency staff has had a number of meetings with Penn 6 Entertainment representatives, as well as the Retama Park 7 interested parties, to develop solutions to certain 8 operational problems which have occurred at Retama Park. 9 Penn Entertainment management has been engaged 10 and helpful in this review. We appreciate very much the constructive approach to resolving these issues. And we 11 are confident that this will continue. 12 Now, at this time, I would like to invite 13 14 Director Cook to come forward. I am going to ask 15 Commissioner Kleinschmidt to join her at the podium, 16 please. 17 We would like to recognize Commissioner Kleinschmidt, for his service to the Commission. 18 19 Commissioner Kleinschmidt has indicated that he will be 20 retiring from the Agriculture Commission at the end of this month, and will no longer be able to serve as the Ag 21 22 Commissioner Sid Miller's designated representative on the 23 Racing Commission. 24

Tim has had a career in public service,including service as a State Representative. And his

1 knowledge was especially helpful to the Racing Commission 2 when we were handed the HIEA, with little legislative 3 direction.

Hold on a second. You are going to make those
presentations when I finish. Seriously.

Tim has had a career in public service,
including service as a State Representative. And his
knowledge was especially helpful to the Racing Commission
when we were handed the HIEA with little legislative
direction on exactly how to administer that \$25 million
annual program.

Tim stepped in and made the good offices of the Agricultural Commission, its grant administrators, and the legal staff to help Racing Commission personnel design the funding applications and assure compliance with all Texas grant laws that apply with dealing with taxpayer money. His efforts largely designated the procedures which we did put in place to administer that program.

His talents and political experience were a great benefit to our efforts as a Commission, and we wish him a restful and prosperous retirement. So, you make your presentation now.

(Applause.)

CHAIRMAN PATE: Thank you. You will be missed.We will now move to today's agenda. The next

Agenda Item 3(b) recognizes Vice Chair Commissioner Doctor
 Connie McNabb for her remarks.

Commissioner McNabb, you have the floor.

4 COMMISSIONER McNABB: Thank you, Chairman.
5 Welcome everyone. This looks like quite the robust group,
6 so I will be brief. Time is trauma; get in and get out,
7 is what my surgeon dad used to say.

8 There are a couple of things. Just these are 9 my observations, because I had the honor and privilege of 10 having a front row seat to this industry and how we do things in Texas, with the HIEA money, you know, and 11 12 everything that happened that made this happen. And I 13 think that the money that comes into the purses has been a 14 godsend for racing in Texas, especially during the last 15 several years.

However, I do want to remind folks that by the statute, and with a legislative review or a letter of intent that was requested by Senator Kolkhorst in 2019 -and those of you who know Senator Kolkhorst, she is a very sharp lady. And she watches how the state's money is being spent.

In the statute, 70 percent of what comes to the breeds goes into purses. The other 30 percent goes to activities that advance the horse industry in Texas. From where we sit, we make sure that the money is flowing

1 through as programmed.

2 But what I would offer is, now we are just coming down off of a legislative session. And I would 3 4 say, for the most part, we were helped greatly. And those 5 of you in the industry who had helped us, thank you so 6 much. 7 But I would say you might want to take a long 8 hard look at what you're doing with that 30 percent so 9 that when you have to answer to someone like Senator 10 Kolkhorst or others, because they do put a pin to things, make sure that you can say, this thing that we do with 11 this 30 percent actually benefits the horse industry in 12 13 Texas. 14 I do have to commend the AQHA. I know they 15 take it seriously. They put on -- and the HIEA was not 16 the only money. But it contributed. 17 And it was a great event up at College Station, Bryan-College Station for the World Youth equine 18 19 competition. But nevertheless, you know, horse shows, you 20 name it. But if people are using money for things that don't really stimulate the industry, I would say, be ready 21 22 to answer to to state senators and other legislators. 23 So, you know, I think we just need -- we can do 24 a better job and we can stimulate the industry. Because 25 that is why the Legislature made this money available.

And we don't want it to go down. We would like to see it
 go up.

My only other observation, and as we talk about race days, we have charity days. Our role, and when I came in, we required that any charity that you all list as being one of your recipients for charity days be a valid non-profit with a current 990.

Race track chaplaincy is always one, and they
need every penny they have. And they do God's work on the
back side of the racetrack.

I would offer to you, as business people, because really, that is the business we are in, there are lots of charities out there. And I am not saying that any of your selections are bad. I am just saying, a lot of charities can also drive attendance, and get people who -you know, good will in the community.

So, from where we sit, a valid 990, yea verily. And that is our job. But I think that since this industry is really making a big turn, I think that there are opportunities, and doing good is good business.

21That is all I have for today. Thank you, sir.22And I look forward to the rest of the meeting.

CHAIRMAN PATE: All right. Thank you,Commissioner McNabb.

The next item, Item 3(c) opens the floor to any

Commissioner who wishes to make remarks. Are there any 1 2 Commissioners who wish to make remarks? 3 COMMISSIONER MACH: Yes. I just want to thank Commissioner Kleinschmidt for his service. Thank you. 4 5 CHAIRMAN PATE: Press the button and talk. 6 COMMISSIONER KLEINSCHMIDT: I just want to 7 thank all you folks. I know that when I started years ago 8 that the industry, everybody from the horse breeders to 9 the racetracks, there were a lot of you all that helped 10 me, you know, learn a lot about what is going on in this particular business. 11 12 I want to thank you for your patience, and for 13 the help you gave in helping the Racing Commission move 14 forward. But again, thank you for your patience. I have 15 enjoyed working with the industry over these last few 16 years. So, thank you for the opportunity. 17 (Applause.) CHAIRMAN PATE: All right. Now, Agenda Item 4. 18 19 Public comments. 20 Dinorah, has anyone signed up for public comment? 21 22 MS. CHIU: No, Chairman. 23 CHAIRMAN PATE: All right. Staff reports. We 24 now move to item, Agenda 5(a), and the Executive 25 Director's Report. ON THE RECORD REPORTING (512) 450-0342

General Cook, give us your report, please? 1 2 MS. COOK: Good morning, Commissioners. Ladies 3 and gentlemen. First, I do have to apologize for that 4 flub on the presentation. We haven't given a lot of 5 presentations here. 6 Now, I come from a military background where it 7 is very regimented. And we rehearse it. We did not 8 rehearse it, and so I apologize. But we certainly 9 appreciate your service and we do want to do more 10 recognition. I mean, we have done a few here. And we need 11 to do many, many more. I have looked at other Commission 12 13 meetings across the state, particularly on the part of 14 public safety, to try to see what best practices are. And 15 they always recognize great folks when they have their 16 meetings. 17 So what I would like to do quickly in my report this morning is cover three key items: Agency operations 18 19 for '23 and '24, horse racing industry efforts, and the 20 greyhound industry future. First, as we close out fiscal year 2023 at the 21 22 end of this month, I want to call your attention to the 23 work being placed in the Agency. Since our last Committee 24 meeting, every employee has worked long hours, not only to 25 support continuity of Agency operations on an ON THE RECORD REPORTING (512) 450-0342

administrative level, but also in supportive of live 1 2 racing. 3 As Sam Houston closed down, Lone Star closed down, Retama Park started up, and Gillespie County Fair 4 5 started up. For example, Jill Ward. 6 Please stand up, Jill. 7 (Applause.) 8 MS. COOK: Jill Ward is our contract management 9 specialist who has worked diligently to apply the 10 additional funding we received through SB30 to purchase 11 items required for admission with an accelerated timeline, 12 while also traveling to Gillespie County Fair live racing 13 events on the weekends to support licensing. 14 Jill, who was our Employee of the Month for 15 August 2023, is but one of the examples of the willingness 16 to set aside a job title and tackle any task required to 17 support the Agency mission. I would also like to recognize Ernesto 18 19 Palacios, who is our financial examiner. Who also went 20 out to Gillespie to help with licensing. 21 Leonard Buchanan, who set up all the IT today, 22 who is our CIO, and went out at a moment's notice and 23 filmed the races at Retama on a Friday night with an hour 24 and a half notice, so that we could run live racing when a 25 camera failed.

Dinorah Chiu, who is the CFO and also is 1 2 running a licensing program, who is filling in for Phil today. And we'll talk about that in a moment. 3 4 Vanessa Zuniga, whose job title is legal 5 assistant, who helps me run payroll every month, so we can 6 all get paid. 7 Charlie Hallam, who recently lost his wife, has 8 come back to work, raring to go and is really supportive. 9 Great investigations, being the only senior investigator 10 that we have right now. And John Ferarra, who is one of our stewards, 11 has spent countless hours at Retama, assisting the safety 12 inspections. 13 14 We also celebrate the return of Virginia 15 Fields. We welcome her back to this Commission meeting. 16 And we also welcome our new Deputy General 17 Counsel, Mary Winston. Mary. 18 (Applause.) 19 MS. COOK: Mary brings incredible experience 20 from the Texas Department of Licensing and Regulations to 21 our legal team. 22 As some may know, our Chief of Staff Phil 23 Fountain suffered a broken arm and a fracture to his hand 24 while traveling overseas for the military department. We 25 hope to have him back to work soon. And I want to call ON THE RECORD REPORTING (512) 450-0342

your attention to the great work that he did during the legislative session that provided members with the critical information required to make decisions that assist us in bringing the Agency to a fully functional organization.

In addition to the recognition of the Agency staff, which, you know, all of them live up to the motto, excellence starts here. We are starting a safety campaign that we'll launch next month. The hashtag will be #SafetyStartsHere.

And our focus will be to catch people, i.e., licensees doing something right that reduces risks, or furthers the safety aspect of our mission. We expect to begin recognizing great folks who exemplify the safety champions we hope to create next month. More to follow on that.

17 In terms of the Agency planning for 2024, included in your meeting materials, pages 3 through 7, are 18 19 the Texas Racing Commission '24-'25 budget. What is 20 important to understand about this budget is -- although 20 percent of the funding is now General Revenue, and that 21 22 is a major step in changing the funding mechanism for the 23 Agency -- we still have far to go to be able to realize 24 our strategic call of bringing the Agency to full 25 functionality.

You will note on page 4 that the Legislature provided an additional 18 FTEs for the Agency, bringing our total to 57. In the past few years, including 2023, the Agency did not have sufficient available budget to fully fund the existing 39 FTEs.

Although the supplemental funding we received provided us the ability to hire an additional eight FTEs this year, we did not receive the funding until about a month ago. Therefore, we only had sufficient time to recruit and hire one FTE, the mighty Mary Winston.

11 So we'll end this year with 32 FTEs on board. 12 We have three additional new hires starting on our 13 investigations team that will start on 1 September, which 14 will increase our capability to address integrity and 15 safety issues across the state as in live racing 16 operations.

17 And we are also recruiting for other critical positions, should anybody be looking for a job, including 18 19 veterinarian, med techs, stewards, as well as several 20 staff support positions in IT and Finance to support Agency operations. The reality of our GR dedicated budget 21 22 is that we are not positioned to fully fund the 57 FTEs 23 allocated by the Legislature since our available budget 24 authority after deductions for the DIR-shared technology 25 services program, the DPS criminal background checks, and

1	the Texas.gov services leave us with \$4.9 million in 2024.
2	You might recall that in 2023, we had \$3.4
3	million, which was not enough to fund the 39.3 FTEs. So
4	what I am saying is, we can afford 45 FTEs of the 57
5	allocated, based on the math equation that we have done.
6	And the fact that we have converted our funding model
7	where the senior staff positions are few and the live
8	racing operations get 70 percent of the manpower, so the
9	same manpower model that I implemented when I got here.
10	That is my estimate of what we can afford.
11	So in addition to that, hiring additional FTEs
12	requires the IT support and travel costs as well. So my
13	intent will be, when we go back to the next legislative
14	session, is ask for supplemental. And then try to see if
15	we can get to the 57 and fully execute those FTEs in 2025.
16	Independent of the FTEs, we should still be
17	able to employ some contract staff to support veterinary
18	operations, including drug testing. And I want to
19	recognize the mighty Texas Veterinary Medical Diagnostic
20	Team that is here today.
21	We are grateful for the great work that they do
22	on behalf of Texas every day, their professionalism, and
23	the challenges that we have overcome this year. Because
24	they have their own funding challenges, as we do.
25	And I would hope that anyone that was in
	ON THE RECORD REPORTING (512) 450-0342

support of all of the things that we are trying to do for the great State of Texas at the Commission level, at the Agency level, or at the lab level, would take a look at donating to the lab to provide them additional funding for FTEs and equipment.

Now on to horse racing. As we work toward returning to our rule review project, our main focus is drafting the new Safety and Health chapter for our rule set.

The next meeting will take place October 10th at Lone Star Park. Thank you very much for Leonard Gonzalez for the place. It was Vice Chair Connie McNabb; Dr. Peter Caldwell, our Medical Review Officer; and Mr. John Beech, the jockey's field representative for Texas.

15 Since I come from a profession that focuses on 16 the safety of people involved in high risk operations, it 17 gives me a unique perspective on horse racing that I really don't see in other states. The focus in this 18 19 industry has been for many years on the horses, and their 20 readiness, and their soundness, and their injury rates; not on the human athletes that ride them, or those that 21 22 train and care for them.

When an accident occurs at a track, our focus on the human factors now is informing the way we conduct safety inspection and how we view integrity. There have

been at least three instances of horses injured during morning training hours when an inexperienced human being put that horse on the track when the horse is not ready or healthy to run.

5 Now we have hired Dr. Peter Caldwell in the 6 role of Medical Review Officer, we have the subject matter 7 expertise to actually review jockey physicals, follow up 8 on jockey injuries, and conduct an effective human drug 9 testing program, and inspect our paramedic capabilities, 10 to make sure that we are prepared for all instance.

Look no further than the performance metrics in our budget that have been modified for 2024. And this was not a request that we changed -- a request that we made; it was one that was given to us by the Legislature on page 6.

16 So, our metric used to be -- our breakdown 17 proportion was 2 percent, so 2 percent of the total number of horses at the start. Now it has been dropped to .8 18 19 percent. So that is a reduction in the number of 20 breakdowns that we are expected to have. And I would tell 21 you that I think that everyone in the industry is working 22 very hard to determine what the factors are that lead to 23 that.

I am focused right now on the human factors, whether the humans can see if the track is holding water

1	or if the humans will call it when they see that the track
2	is unsafe. Whether the humans are making the right
3	decision in terms of putting that horse on the track. And
4	I think that is paying off in big dividends.
5	As of today, we are meeting this metric. But
6	this is a challenge that we all have, to continue that.
7	What you will also notice on the same page, is
8	that the greyhound metrics have been zeroed out. And I
9	will talk about that in just a moment.
10	Since most metrics are gathered by calendar
11	year, not fiscal year, as we are required to do here, our
12	goal will not be limited by time or calendar. Rather, our
13	goal will be to continue to review the factors of each
14	accident, and determine which, if any, were preventable
15	and use that information to improve our safety protocols.
16	
17	Our ultimate goal should be no horse or human
18	injuries. But given the high risk nature of horse racing,
19	we can certainly work together to mitigate risk for all
20	participants. Safety is, after all, a shared
21	responsibility for the Agency and the industry. If
22	everyone takes their part in it, everyone will stay safe.
23	On the greyhound industry, stepping back for
24	moment. In April of 2022, I sat down with the greyhound
25	track representative for three licensed greyhound tracks,
	ON THE RECORD REPORTING (512) 450-0342

as well as the Texas Greyhound Association, informed the group that I would not be requesting greyhound funding as a part of the Agency base budget. The budget request that we presented as a line item for greyhound racing, should it return to Texas, was ten FTEs and \$700,000. That request was not adopted by the Legislature.

As we saw over the past year, and through session, both the industry, public in rules committee meetings and Commission meetings, and the Legislature did not approve and actually vetoed that line for greyhound regulation in our budget. Having acknowledged that greyhound racing is essentially winding down in our country, and in the State of Texas.

If you turn back to page 6, you will see that greyhound metrics, as I noted before, have been zeroed out. It is my understanding that the House Appropriations Committee made that decision, because they were not assured that greyhound racing would ever again take place in Texas.

20 So what that means is the adopted budget for 21 the Racing Commission for '24-'25 provides no funding to 22 regulate greyhound racing in the State of Texas. 23 Therefore, it is critical that the racing associations 24 responsible for the three greyhound tracks, whose licenses 25 will be reviewed this fall, communicate early and often

with the staff at the Agency and the Commission on their 1 2 future intent with respect to those licenses. 3 Critical priorities this fall include devoting time for rule review efforts, supporting industry efforts 4 5 to get ready for the 2024 live racing season and 6 recruiting additional staff to provide as much capability 7 as possible for Agency operations. What I believe will 8 benefit the Commission, the Agency, and the industry most 9 in this time of continued and dramatic change, while we 10 are still transforming our agency, is to keep our focus not on the issues we disagree on, but on the main effort, 11 the safety and integrity of horse racing. 12 13 Thank you. 14 CHAIRMAN PATE: Thank you, Amy. I have got a 15 couple of questions. We are talking about the TVMDL here 16 in a few minutes, but my understanding is sometime in this 17 last year, they had an equipment problem. And as a result, testing slowed down, because there is no 18 19 redundancy with respect to that equipment. And the 20 testing equipment we are talking about is guite expensive. What is it --21 22 MS. COOK: It was. Two of the machines are a 23 million dollars each. CHAIRMAN PATE: A million dollars each. 24 And 25 so, just kind of putting that out there. If anybody is ON THE RECORD REPORTING (512) 450-0342

really interested in giving that wonderful lab -- and if 1 2 you have never toured it, I advise you to go see it. 3 It is really a remarkable place. It is a great 4 place that somebody could give some money to. And what 5 they are doing out there, testing and trying to get ahead 6 of what the cheats are doing in trying to drug animals and 7 that kind of thing. 8 And it is remarkable. But they have a funding 9 issue there, like everybody does. And that redundancy of 10 equipment would be a wonderful supplement, obviously. 11 And also, you didn't say the most important thing about Phil is he fell off a horse. So that is how 12 he was hurt. What he was doing in the military in Chile 13 14 on a horse, I don't know. 15 MS. COOK: So Phil has a public affairs 16 assignment in his military department role. And he 17 thought it would be a great photo op. So, he got on the horse, and the horse bolted. He got thrown off. 18 19 So, I told him he was fortunate it didn't 20 happen in the Great State of Texas where we could all take 21 a picture. So he is doing well. But we hope to have him 22 back soon. 23 CHAIRMAN PATE: All right. Commissioners, do 24 you all have any questions for Amy? 25 (No response.) ON THE RECORD REPORTING (512) 450-0342

17	reasonableness of the fees associated with the agreement
18	to be executed by the Directors of both the Racing
19	Commission and TVMDL.
20	In the past, there has been a memorandum of
21	understanding. But since 2022, the agreement outlines the
22	fees specifically. In addition to the fees before you,
23	hair testing fees are also included in the agreement.
24	The cost of services begin on page 13, through
25	page 15 of the agreement. It contains provisions for

1 TVMDL to now store both the specimens and cells, as well 2 as split samples. The cost for storage of specimens is 3 also contained in the agreement. The cost for sending 4 split samples to another agency-approved laboratory is 5 also in this agreement.

Finally, the Texas Racing Act provides that the Charges for the services must be "forwarded to the Commission for the approval of the reasonableness of the charges." Those charges include expenses incurred for travel, lodging, testing, and processing of test results.

11

The Commission should "determine whether those 12 13 laboratory charges are reasonable in relation to industry 14 standards by periodically surveying drug testing, 15 laboratory charges comparable through the United States." 16 Staff today, prior to the meeting, made such comparisons, 17 which were drawn with the Veterinary Diagnostic Laboratory at the University of Missouri, industrial laboratories, 18 19 and the Laboratory at UC Davis. All were found to be comparable with the laboratory charges. 20

Dr. Mays is with TVMDL and here today as a resource witness should there be any questions for TVDML by the Commission. Staff would recommend that the Commission on motion find these charges in the 2024 interagency agreement are reasonable in relation to

industry standards and approve the reasonableness of those 1 2 charges for that motion. 3 CHAIRMAN PATE: Thank you, Virginia. 3	37 of your meeting materials is a short Executive Summary
4	of the changes to the two-year extension agreement before

The 6 next item is Agenda Item 8(c), (1) and (2): Racetrack 7 proceedings; a discussion on the ownership and management 8 of active racetrack licenses scheduled for review under 16 9 Texas Administrative Code 309.53. 10 Amy, would you please address the first item, Valley Race Park, please. 11 12 MS. COOK: Thank you, Judge Pate, Commissioners, ladies and gentlemen. 13 14 So, we have eight racetrack license reviews 15 scheduled this fall. Just a little background -- Judge Pate had mentioned it in his intro -- was that 16 17 Representative Kuempel asked the Agency staff in August of 2022 for a status on all of the current racetrack 18 19 licenses, there being ten total. 20 What we found when we tried to write a letter 21 and respond was that I wrote him one letter, and then we 22 went through more records, and found some context in paper 23 records. Corrected that record, corrected that letter, and sent back another letter. And then found out that letter 24 25 was wrong.

And then actually just went over to his office and said, we are going to do a racetrack license review. So there is a typical yearly or annual, or five-year review on licenses. What we found is we have a real need to bring our records up to date, and make sure they have clarity.

7 One of the items that I think it is important 8 for all the folks who have business interests in this 9 community to know is that one of the practices that 10 Virginia and I were not comfortable with, and we changed when we took our positions was when the Commission votes, 11 12 as you just said, on the tote agreement, we do a Commission order that you sign. And so it is a great 13 14 practice that Virginia recommended.

15 In the past, what had happened was the Executive Director would sign a document saying this is 16 17 what the Commission said. And that is where we have lost some clarity in terms of motions and orders from the 18 19 Commission. And that is not something we can't overcome. 20 But it does make it more difficult, as the Agency staff looks at a record for a business license or anything else, 21 22 to make sure we have that clarity.

23 So I am really appreciating it, although it has 24 been quite a lot of paper that we have asked for and paper 25 that has been sent to the Agency. We were missing key

1 For example, the Retama Race Park license, documents. 2 actual license from 1993, which Mr. Straus provided us. We had everything else, but we didn't have that. 3 4 So we really appreciate being able to get that 5 from you. Our intent is, bring the paper records to where 6 they should be historically and then scan them in 7 digitally so then it isn't so difficult to figure out, you 8 know, what is the history on some of these licenses. 9 So we are treating some of the licenses as 10 active, for a lot of different reasons. The greyhound 11 licenses in particular are all being treated as active 12 right now, because there is no record that they were ever 13 inactive or in any other status. 14 So if you have questions about why their 15 status, that is erring on the side of the licensee, in 16 terms of going through the review. And it is really meant 17 to not impair any business interests. So the first racetrack license that we are 18 19 going to review, and of course, as Judge Pate mentioned, 20 these are all for presentation and discussion, not for decision by the Commission yet -- in the interest of 21 22 allowing the parties that are interested in the license to 23 present anything they would like to the Commission for consideration. 24 25 So the Valley Race Park license is located in ON THE RECORD REPORTING (512) 450-0342

Harlingen, Texas. And you will see up on the screens what
 the factors are that need to be considered. It is also in
 the Commission meeting materials.

And I thought it was helpful for the full body to be able to see that you really have four criteria that you look at: the financial stability, the ability to conduct live racing, the ability to construct and maintain a racetrack, and other good faith efforts to get back live racing.

Because fundamentally, live racing, and doing live racing well and safely and with integrity is sort of the main thing with respect to a racetrack license. So those are the factors to be considered.

With respect to Valley Race Park, they did request live race dates for 2023. And then Dwight Berube, who has now been replaced by Mr. Pettigrew, notified me on April 11, 2023, they would be unable to bring those live race dates.

At this point, Valley Race Park holds an active operating greyhound track. And as we noted earlier, the Legislature has not appropriated any funds to regulate greyhound racing.

23 So I am going to turn it over now to a 24 representative of Penn Entertainment. They have a 25 presentation they would like to provide. And then, we

MS. MCCORMICK: Good morning, Chair and Commissioners. My name is Marnie McCormick, and I am a lawyer here in Austin. I practice with the firm of Duggins Wren Mann & Romero.

7 And over the last twelve years, I have had the 8 privilege and pleasure of representing Penn Entertainment 9 and its affiliates in several Texas Racing Commission 10 proceedings that affected racing licenses, both active and 11 inactive in the State of Texas. And so today, I have the 12 privilege of introducing our team who has come, put 13 together a presentation on the Valley Race Park license 14 for you all.

And we have several people who are going to speak, and other folks who are in attendance here. And I just wanted to point them out to you, and orient you so you know who is here to give you information and answer the questions that have come out in our discussions with staff, leading up to this meeting.

The first person I would like to introduce is Todd George, who is Executive Vice President of Operations for Penn Entertainment. And he is here on the second row. Thank you.

Next is Chris Rogers, Executive Vice President

and Chief Strategy Officer. Next, Erin Chamberlin, Senior 1 2 Vice President of Operations. 3 We also have Bryan Pettigrew here, Vice 4 President and General Manager of Texas racing operations. 5 And finally, Chris McErlean, Vice President of Racing 6 Operations. 7 And I won't take up more of your time right We will get right to it. 8 now. 9 And Mr. George, if you want to come up and kick 10 things off. Thanks. MR. GEORGE: Thank you, Marnie. I'm Todd 11 George. I oversee operations for Penn. 12 Judge Pate, Vice Chair McNabb, Commissioners. 13 14 And a special thank you to Commissioner Kleinschmidt, 15 Executive Director Cook, Deputy Director Grigsby, General Counsel Fields and staff. 16 17 Thank you all very much for the opportunity to present to you today. We will go quickly, so we can get 18 19 back outside and enjoy some more heat. It has just been too nice in here. 20 So a brief history of Penn Entertainment. 21 We 22 were founded in 1972 as the Mountainview Thoroughbred 23 Racing Association. Over the years, through development, 24 both greenfield and brownfield development as well as 25 various acquisitions, we have grown into the largest ON THE RECORD REPORTING (512) 450-0342

racing and regional gaming operator in the U.S. 1 2 Today, Penn -- our NASDAQ symbol is PENN. We 3 operate 33 properties in 20 states, including eleven racetracks. A collection of unique and differentiated 4 5 brands across the U.S., including multiple casinos and 6 integrated racinos. Next slide, please. 7 Our racing operations specifically, nationwide, we are the leader in operations and management of 8 9 pari-mutuel racing operations. We have eleven racetracks 10 in eight jurisdictions. We have over 1,200 live racing events in '22, thoroughbred and Quarter horse as well as 11 harness racing. 12 We had \$1.1 billion in pari-mutuel wagering in 13 14 '22, including live import and export simulcasting. As 15 well as five off-track wagering locations in three states, 16 with a national advance deposit wagering operating in 24 17 states. To date -- you probably recently saw our 18 19 agreement with ESPN. We will be doing more in the field 20 of sports betting as that expands throughout the country. But exciting times for Penn, as well as getting back to 21 22 our roots with horse racing. 23 So with that, I am going to turn it over to 24 Erin Chamberlain, who oversees regional operations in the 25 northeast, as well as horse racing.

1	MR. ROGERS: Thanks, Todd.
2	Erin is actually going to be after me. I am
3	Chris Rogers. I am the Chief Strategy Officer for Penn.
4	And I wanted to start by just giving a little bit of
5	background on our history in Texas.
6	So it started in 2011, when we joined a joint
7	venture with an entity called MAXXAM. It is backed by
8	Charles Hurwitz. And we acquired ownership ventures in
9	three racing licenses at that time: Sam Houston, Valley,
10	and then Laredo Downs the latter of which we no longer
11	hold.
12	And since this initial investment, we have been
13	able to leverage our experience as a racing operator
14	across the country to bring new innovations to racing in
15	Texas. Including establishing the Houston Racing Festival
16	and the Houston Ladies' Classic, among many other things
17	that we have done.
18	In 2016, we acquired the former Manor Downs
19	license, which will be subject to review at a later date.
20	And then in 2018, we acquired one of our competitors in
21	the regional gaming space called Pinnacle Entertainment.
22	And through that, we assumed management of the contract
23	for Retama Park, which we'll be discussing later today.
24	As you all know, COVID was devastating for the
25	racing industry. We were shut down nationwide. I think
	ON THE RECORD REPORTING (512) 450-0342

we showed significant nimbleness in reacting to that. 1 2 And an example is at Retama Park, we just 3 shifted to an all Quarter horse race meet calendar, as a 4 result of that. And then, in 2021, it is hard for me to 5 believe sitting here today, but there was actually winter 6 storm damage at Retama Park. And we were able to shift the race dates into Sam Houston, which I think was a 7 8 really good outcome for racing. 9 Later in 2021, we did acquire the remainder of 10 our joint venture with MAXXAM. So as a result of that, we 11 are now the full owner of three racing licenses: Sam 12 Houston, Valley, and Hill Lane, which is the former Manor 13 license, which is now inactive. And of course, we also 14 have the management contract at Retama which we will speak 15 to later. 16 Bringing us forward to today, we do have a full 17 calendar of races at both Sam Houston and Retama. And we are very much looking forward to continuing to further the 18 19 great tradition of racing in Texas going forward. 20 And so with that, I will now turn it over to 21 Erin. 22 MS. CHAMBERLIN: Thank you. So thank you, 23 Chris. Thank you, Todd. And thank you, Judge Pate and 24 Commissioners, Executive Director. It is great to be here 25 today. ON THE RECORD REPORTING (512) 450-0342

So our investment in Texas, as Chris said, 1 2 based on our acquisition costs, our capital costs that we've funded in, we have invested well over \$110 million 3 into the State of Texas in just over that decade. We have 4 5 also funded nearly \$11 million in operating losses since 6 2011. 7 But I think even more importantly, we employ 8 nearly 550 team members here in Texas. And we spend about 9 \$7-1/2 million every year on salaries and benefits for 10 those team members. Nearly 50 percent of whom are female, and more than 60 percent of who are minority. So we are 11 really proud of that. 12 We are also really proud of our commitment to 13 14 local organizations. As a company, Penn Entertainment is 15 highly focused on making sure that our properties that we 16 operate across all these jurisdictions are really attuned 17 to the jurisdictions in where they live. The communities where they operate, and where their team members live. 18 19 And so Texas is no different for us. And so 20 our team members and our property leadership in Texas have been great supporters of many local organizations. 21 22 In fact, one that was just mentioned, the 23 Racetrack Chaplaincy of America, the permanent League of 24 Disabled Jockeys fund and many others here in Texas. So 25 we are really proud of that commitment and intend to ON THE RECORD REPORTING

1 continue to do that.

2 With that, I am going to turn it back over to 3 Chris, who is going to be able to address some future 4 guestions.

5 MR. ROGERS: Yes. So I would just like to 6 conclude by addressing the elephant in the room here, 7 which is that Valley, as you know, is a greyhound track. 8 And we are unable to conduct live racing there today on 9 the greyhound side.

As a result, we have been evaluating all of our potential options, including the potential of converting into a Class 2 track. It is worth noting that Cameron County has approved horse track racing by majority vote, a really strong majority vote. So we think potentially that could be an option.

And what we would like to do is be able to 16 continue to evaluate our options with the Commission and 17 staff to see what is the best potential outcome for this 18 19 license. And with that, I will open it up for questions. 20 CHAIRMAN PATE: I have a question. Are y'all 21 doing simulcast at the Valley? 22 MR. ROGERS: No. 23 CHAIRMAN PATE: All right. 24 COMMISSIONER McNABB: I have something guick. 25 If you have an intent, as your negotiations and the plans

proceed, we are very interested. I mean, the health and 1 2 welfare of the racing animals, and that includes training, as well as racing, so where, how, what kind of service. 3 4 You know, all of those things, we would like to see some 5 intent. 6 Because as far as we are concerned, whether you 7 have an active license or an inactive license or 8 relinquished -- are you actively involved or not? So we 9 do look forward to hearing from you, and what your plans 10 are, and how you plan to move forward. MR. ROGERS: Understood. 11 12 CHAIRMAN PATE: All right. Thank you very 13 much, Chris. 14 MR. ROGERS: Thank you. 15 CHAIRMAN PATE: Let me get back to my script 16 here. 17 So I have a recommendation for the MS. COOK: Commission. And that is that given the uncertainty -- and 18 19 anybody that knows me, or that has gotten to know me in 20 this position knows I like to create predictability and 21 lessen the uncertainty, because that helps great things 22 happen in the industry. 23 I would recommend to the Commission that you 24 consider -- the Chair consider appointing an ad hoc 25 committee of two Commissioners and three industry ON THE RECORD REPORTING (512) 450-0342

representatives -- and those could be chosen later. 1 And 2 that ad hoc committee would look at the greyhound industry 3 in Texas. And potentially, you know, what is the 4 transition away from the greyhound industry and the 5 potential for looking at the options in terms of what are 6 our statutory needs -- because there was a Committee 7 substitute during the session on greyhound. 8 It didn't pass. But I think the entire 9 industry, horse and greyhound, has a vested interest in a 10 winding-down process that is statutory rule-based and policy-based that then will allow everyone to have that 11 12 conversation. And then we potentially go into session with 13 14 the right legislative proposals that will make sure that

the right legislative proposals that will make sure that we mitigate the risk on everyone. So if that would be acceptable to the Commission, then I would put that on the agenda for discussion for the next Commission meeting.

18 CHAIRMAN PATE: Yes. This is something that 19 Amy and I have spoken about. And I think it is 20 appropriate. You know, there are these hanging issues out 21 there.

We had a bill in the Legislature, House Bill 4115, that did not get a second reading, so it did not pass. It had specific language in it that simply did away with greyhound racing, period.

And it also had a resolution of this lingering 1 2 issue of the some $\frac{2-1}{2}$ or 3 million, whatever it is, 3 that is horse racing money. Just a small piece of it that 4 was placed with the Texas greyhounds to enhance their 5 further racing, which they are not going to do. 6 Last year, I requested an opinion from the 7 Attorney General. The Attorney General gave his opinion 8 in response to a request by the greyhound people for us to 9 make a distribution, that at least the Commission thought 10 that request was outside of the statute. The Attorney General's Office agreed with us. 11 So we cannot make that distribution. But we 12 13 need to deal with that money. That bill gave the money 14 back to the -- actually gave it back, as I recall, to the 15 Commission for redistributing to the various horse 16 incentive programs and so forth. 17 So I think this needs to be looked at. I have spoken to Commission Moore about chairing this committee. 18 19 And so we will follow up next meeting, and we will talk 20 with some industry people. It will be open, if anybody 21 wants to come and visit whenever they meet. 22 But I think we need to at least raise the 23 issues so the Legislature can consider what they want to do with this situation. Because again -- I mean, right 24 25 now, we are continuing, I think, to accrue money in the ON THE RECORD REPORTING

Texas-bred program. And it is held in trust for the 1 2 greyhounds. 3 But there is not going to be greyhound -- we 4 can't distribute the money. So it is just kind of a 5 screwed up deal that we need to get worked out. 6 And Commission Moore, I twisted his arm. He 7 said he would do it. So we will be back with some more 8 specifics on that at our next meeting. All right. 9 MS. COOK: Yes, sir. Thank you. 10 CHAIRMAN PATE: Thank you for bringing that to the attention of everybody here. And we invite your 11 12 ideas. We would like to go in to the next -- here we are 13 just out of the last session. 14 But we'd like to go into the next session with 15 really a firm idea of making sure the Legislature is aware 16 that there is a statutory problem out there that needs to 17 be resolved. Just because of the fact of the matter is, there is no greyhound racing. So, thank you. 18 19 MS. COOK: So, on to the next agenda item, 20 which is Retama Park. I am sorry. 21 COMMISSIONER McNABB: Can I go backwards to 22 Valley just a moment? 23 MS. COOK: Absolutely. 24 COMMISSIONER McNABB: And please, I didn't 25 sleep at Holiday Inn. And I just went to vet school, so I ON THE RECORD REPORTING (512) 450-0342

am not a lawyer, I'm sorry. I'm just an ordinary vet. 1 2 If you are looking for Valley to have an active, or an active other, or an inactive license, I 3 assume that from a business point of view and entering 4 5 into a business agreement, you want to have something that 6 says active. But active does then imply that you are 7 asking for race dates, and that is not going to happen for 8 a while. 9 So just help me understand why you would 10 request active as opposed to active other, or inactive. Just so I can understand from your side of the equation. 11 MR. ROGERS: Look, our preference is to 12 continue as an active license. And look, we have made 13 14 significant investments in the license, and we think in 15 order to further our business interests, that is the best 16 potential outcome. 17 However, we understand the challenges with that, given what we have discussed and the fact that 18 19 greyhound racing is unbooked today. So our preference would be to continue as an active license while we sort 20 21 through the potential alternatives. 22 COMMISSIONER McNABB: But for horse racing. 23 You are saying for Class 2 -- an active license for a 24 Class 2 horse track. Would that then imply that you had 25 asked for dates that you would run on one of the other ON THE RECORD REPORTING (512) 450-0342

1 tracks, or just --

2 MR. ROGERS: Understood. In the event we were 3 to apply or convert into a Class 2, yes. We would be 4 seeking an active license, and then going through the 5 process of building the track, an appropriate track, and 6 seeking racing dates.

7 COMMISSIONER McNABB: Helps me understand your8 thinking.

CHAIRMAN PATE: Yes.

MS. McCORMICK: Yes. I am sorry. I just wanted to add one thing about timing, is because the license for Valley is currently active, it was our understanding that those licenses are reviewed every five years. And under the Commission's current rules, when a change of control proceeding happens, that resets the five-year clock.

17And the last change of control proceeding18affecting the Valley license was in 2021. So, we are --

19 CHAIRMAN PATE: We are reviewing it. We are 20 reviewing it, okay.

MS. McCORMICK: I absolutely understand that, for sure. But I am just explaining why we thought that we had some time to have these discussions about the future of the licensing.

CHAIRMAN PATE: I think the change condition --

the increasingly clear condition of no greyhound racing kind of begs a solution. And I think if we work with industry and can come up with something reasonable and present it, I think if we have enough interest in appropriate legislators, that they will work something out and pass it.

But we need to review all these. And y'all's situation with no simulcast is a little bit different. Where we had simulcast issues, we have this interface of you are being awarded race days for races that are never going to occur, but it is a legal fiction that allows you to open up the simulcast.

I mean, we are going to have to address that. And we are not quite clear in reading the statute, our enabling statute, the Texas Racing Act, that that actually is a proper application of the Act. We are not saying it isn't. We are just -- we are looking at it very carefully.

We have had these discussions with representatives of all the greyhound people. They know what our thinking and what our concerns are.

COMMISSIONER McNABB: No one ever anticipated that we would be in this situation. So, it is just -- as we can better understand you from your business perspective, where you are going, and what you are

1 planning to do.

2	Because then, there are certain regulatory
3	hoops you have to jump through, I am sure, certainly, with
4	all the different states you deal with, all the state and
5	federal entities. We don't want to interfere, but there
6	is also places where we don't want to miss. We don't want
7	to miss those times that we need to have a conversation,
8	because we didn't understand what you were doing or didn't
9	know things got away.
10	CHAIRMAN PATE: Amy, is there anything else
11	that I missed in there that you would add?
12	MS. COOK: I think I like to provide hope.
13	So if you have had a local election for horse racing in
14	that county, you can certainly write me a letter that
15	says, we would like to have an Agenda Item for September
16	to ask the Commission whether they would open a race date
17	application for that county, for a Class 2 horse track.
18	So that to me rather than waiting, that to
19	me would be a way to start going down that path,
20	independent of the fact that we will then again set for
21	discussion an action by the Commission, the status of
22	Valley Race Park's license.
23	Does that make sense? So you can move. You
24	can run down both tracks at the same time.
25	That would be because there is no there's

an urban legend that converting or redesignating is 1 2 actually in the statute. Actually, if you Control-F, it is not in there. 3 4 So I want to provide you some hope. I think 5 that is the path, is to go ahead and start running. Ιf 6 that is really what you want to do, you want to do a Class 7 2 horse track in a county, and there is already a local 8 election, you need to provide the request. 9 And then, I need a Secretary of State 10 certification that that election took place. So, that 11 should be pretty easy to -- with your letter. 12 MS. McCORMICK: We look forward to talking to 13 you about this. 14 MS. COOK: Okay. I look forward to that. 15 MR. ROGERS: I wish we had all the answers 16 here. But what I can say is that we are very much an open 17 book and willing to work with your staff, as well as the Commission, to make sure we find the right --18 19 MS. COOK: Great. 20 CHAIRMAN PATE: Yes. I mean, we're in the 21 business of encouraging racing, okay. But we want it to 22 be safe for both the equine athletes as well as the human 23 athletes. That is the bottom line. 24 And we want the pari-mutuel wagering to be 25 fair. So, that is it. All right. Thanks. ON THE RECORD REPORTING

1	MR. ROGERS: Thank you.
2	CHAIRMAN PATE: Let's move on to Retama.
3	MS. COOK: All right. So, again, one page on
4	the [inaudible]. The factors that we considered are the
5	same. Retama is also considered inactive, a Class 1 horse
6	track license. Just like you did here in the initial
7	presentation on Valley, I am sure that the Penn folks will
8	address it again. There was a time when Retama had
9	thoroughbred racing and Quarter horse racing, now it only
10	conducts Quarter horse racing.
11	As everyone in this room knows, there have been
12	some recent challenges at Retama. There were 22 race
13	dates granted this year, and it appears that we will
14	successfully conduct 22 live race dates this year, with
15	some rescheduling that we had to do.
16	A review of our records reveals that Retama
17	holds currently an active operating, Class 1 horse track
18	license. Although Retama Park has had some challenges
19	complying with the Texas Racing Act with respect to safety
20	issues, the management team has taken several steps toward
21	achieving compliance during the past years to improve the
22	track's performance in increased racing and training
23	opportunities for horsemen.
24	So with that, I will let the Penn Entertainment
25	folks come up and give their presentation to you.

MS. McCORMICK: I'm back just to introduce some 1 2 additional folks who have come up for your review of the 3 Retama license. And those are, first, members of the 4 management committee and officers and directors of the 5 entity that holds the title to the Retama license, which 6 is called Retama Nominal Holder. 7 And those gentlemen are all here on the front 8 The first of whom doesn't really require an row. 9 introduction, but Mr. Joe Straus, Jr. And then we have 10 Ken Polasek next to him, and Phil Swinney next to him. And Mr. Polasek and Swinney are also Board members of the 11 Retama Development Corporation, which owns the track and 12 the beneficial interest in the license. 13 14 And so, I will sit down with that. Mr. 15 Polasek, I think, will say a few words. And then that 16 group will be followed by the same group that you heard 17 from --CHAIRMAN PACE: Great. 18 19 MR. POLASEK: Good morning. Yes. Ken Polasek, citizen of Selma and also President of the Retama 20 21 Development Board. Mr. Chairman, Commissioners, thank you 22 for the opportunity to present the background in ownership 23 of the Retama Park. 24 As you can see by the diagram, it is probably a 25 different organization than other tracks. The Retama ON THE RECORD REPORTING (512) 450-0342

Development Corporation was established in January of 1993, formed by the City of Selma as a local government corporation by filings of the corporation with the office of the Secretary of State.

5 Members are appointed by City Council for the 6 board of directors that serve for two-year terms. The 7 Retama Development Corporation, as the slide has 8 mentioned, was formed by the City. It owns pecuniary and 9 beneficial interests in the racing and simulcasting 10 aspects of the license, and owns Retama Park, fixed and other assets, and land under the track. So the RDC is the 11 beneficiary of the operations. 12

The other element of the structure is the Retama Nominal Holder, LLC, which is the owner's nominal interest in the racing and the simulcasting. So pretty much anything.

As part of this setup, the RDC meets quarterly, as needed. And day-to-day management, as you can see in the red block, has been delegated to PNK (SAM), LLC, via a management agreement. PNK (SAM), LLC, is a subsidiary or affiliate of Penn Entertainment, Inc.

And as part of oversight, the Board typically considers the following. We look quarterly at least, in financial reviews, operational updates, independent auditor review, annual audit, take action as necessary.

Annual budgets, capital expenditures, peruse leases and 1 2 space at the facility. Reviews requests, and authorizes uses of the facility, such as festivities, holiday light 3 4 shows, and other special events. 5 And so, as members of the Board, I am 6 President. And then, my Secretary is Mr. Phil Sweeney. 7 Other members of the Board who are not here are Mr. Gary 8 Baber, Charles Eads, and James Parma. 9 With Retama Nominal Holder, Mr. Phil Sweeney is 10 also there. Joe Straus, as you've introduced, and then myself. So that is the organization. 11 12 And let me go to the next -- that is it. And 13 then I am proud to now carry on with Mr. Todd George, 14 Executive Vice President. 15 CHAIRMAN PATE: Can I ask you a question --16 MR. POLASEK: Yes, sir. -- first, before you give up 17 CHAIRMAN PATE: the podium? So what exactly is the deal with Retama 18 19 Development Corporation? Under the management contract, 20 are y'all responsible for capital improvements, or is that 21 a responsibility under or by your management company? 22 MR. POLASEK: It is by the management company. 23 CHAIRMAN PATE: Okay. So, that is part of that 24 deal. So, y'all simply are the title owners of the 25 property.

MR. POLASEK: That's correct. 1 CHAIRMAN PATE: Correct? Okay. And so -- and 2 we also took a look a one of the financial statements. 3 4 Y'all issued some revenue bonds originally, whenever --5 and you've been accruing interest on it. I think there is 6 something -- 630-, \$700 million something owed on it now. 7 And those bonds are non-callable. Correct? 8 Ι am trying to understand the financial stability. 9 10 MR. POLASEK: Yes. It's a very good question, sir. 11 CHAIRMAN PATE: So, if they are non-callable --12 13 MR. SWINNEY: Yes, sir. They are non-callable. 14 CHAIRMAN PATE: So it is just perpetual debt. 15 MR. SWINNEY: There are a few stipulations that 16 would call them. But they are generally considered noncallable. 17 18 CHAIRMAN PATE: Okay. 19 MR. SWINNEY: If there were, you know, a gift -- yes. To answer your question --20 21 CHAIRMAN PATE: Well, what are the stipulations 22 that would call it? MR. SWINNEY: If we make a certain amount of 23 24 money. If a certain amount of income is received, then 25 they can become called -- certain bonds, certain ones can ON THE RECORD REPORTING (512) 450-0342

1 become called.

2 CHAIRMAN PATE: I see. Okay. So if you suddenly had a windfall of some kind, there is a --3 4 MR. SWINNEY: A significant windfall. 5 CHAIRMAN PATE: There is a trigger that would 6 require payment. Okay. All right. Thank you. 7 MR. ROGERS: And if I could just clarify one 8 We heard the Commission loud and clear, as far as thing. 9 the responsibility, and the single point of contact. And 10 although the organizational structure is a little complicated. And I will blame the lawyers for that. 11 12 When it comes through the operations, it is 13 very clear. Which is, Penn is the operator and the 14 management contract. If there is an issue, Mr. Pettigrew 15 is the single contact for you. 16 CHAIRMAN PATE: Got it. Thank you. 17 MR. ROGERS: And with that, I will turn it over to Todd. 18 19 MR. GEORGE: Thank you again. So as you heard 20 Executive Director Cook mention before, and this is a 21 great way to frame it. These are the four pillars that we 22 looked at. 23 We are looking at licensibility. So, I will go 24 to financial wherewithal, and then I will turn it back 25 over to Brian and Erin to cover the next three. ON THE RECORD REPORTING (512) 450-0342

So we are a publicly held company. All of this 1 2 information is available publicly through our SEC 3 statements. But we are the primary backstop for all 4 operational costs. 5 We have been doing this since 2013 because of 6 our acquisition of Pinnacle. So we are the largest 7 regional racing and gaming operator, you heard me talk 8 about that before. 9 In 2022, our most recent year end, we had 10 revenue of approximately \$6.4 billion. In 2022, even though our profitability of \$1.94 billion and that our 11 12 market cap was sitting at \$4.18 billion. So, we feel that 13 with those three data points, we are demonstrating the 14 financial wherewithal to operate the racetrack. 15 With that, I will turn it over to Brian and 16 Erin. 17 So, but what is the commitment CHAIRMAN PATE: of Penn to Retama? I understand y'all are a big company 18 19 and you have other assets and so forth. 20 But I have toured Retama. I assume you have 21 been out there recently, too. And since I became Chair --22 I mean, when Amy first came, we took it to her. 23 And there were immediate repairs that were 24 required in the stable area. And then, of course, there 25 has been the freeze. And there has been -- we had the ON THE RECORD REPORTING

power outage several weeks ago, and all of these
 developments.

3 So I am just kind of wondering out loud, is the 4 commitment unlimited? Or is there a protocol in your 5 relationship with the Retama Nominal people, or with the 6 City, that requires you to maintain certain things. And 7 then there is discretionary items on others. 8 How does that work? 9 MR. GEORGE: So Bryan and Erin will go through 10 more detail on that. But I can tell you approximately two weeks ago, we had a very productive meeting, I think, with 11 Executive Director Cook. And in the last two weeks, I 12 think, we have demonstrated significant improvement, made 13 14 some glaringly obvious needed improvements, including red 15 paint. But everything --16 MS. COOK: Touchdown. 17 CHAIRMAN PATE: I heard that story. MR. GEORGE: So did I. I said, my face turned 18 19 that color of red. 20 But so as it relates to whether it is unlimited 21 or -- we will make -- there are just some obvious 22 improvements that we will continue to make. And the other 23 thing that you will hear Erin and Bryan talk about -- I am 24 trying not to be a thunder stealer. We have a great -- it 25 really is about the human capital, not just the downward ON THE RECORD REPORTING (512) 450-0342

1	capital improvement, but the human capital.
2	And because of our size and scope of
3	properties, we have a great sister property over in
4	Louisiana that we have mobilized to help with a lot of the
5	facilities operations, making the needed improvements
6	there. So that is already happening now.
7	And then, you will see that continual
8	improvement as we get ready. I think we will have a
9	fairly robust plan between the end of this race session
10	and the next one. And you will hear again I'm not
11	trying to steal thunder. But you will hear Bryan and Erin
12	talk about that.
13	CHAIRMAN PATE: Then I have one other question.
14	I don't know whether it is yours or whether it might be
15	Erin's.
16	And that is, is there a marketing plan? I am
17	going to be asking this of every track, not just but
18	Sam Houston and also Lone Star. Because this is just an
19	observation. And I don't know the answer.
20	I mean, as I mentioned in my earlier remarks,
21	and particularly as a result of the proposed casino
22	legislation that was filed in this last session, there
23	appears to be for the last 30-something years, a perpetual
24	hope that these licenses are placeholders for casino
25	gambling or expanding gambling in Texas. So far, that has

1 not been a very good bet.

MR. GEORGE: That is correct, sir.

3	CHAIRMAN PATE: In 40 years, it hasn't been a
4	good bet. But my observation is that there and I don't
5	know whether this is fair or not. But I am asking you.
6	There has been so much focus on that, kind of
7	this hope. As opposed to you know, what we really need to
8	do is figure out if we can get this business that we have
9	of horse racing working, and make it work.
10	You know, and I realize HISA has thrown us a
11	curveball in Texas. And we're not going to go through all
12	that. You all understand where we are on that.
13	But beyond that, I guess I am just kind of
14	interested whether or not there is a commitment to the
15	horse racing as a business enterprise, separate and apart
16	of whatever future promise it might or might not foretell.
17	MR. GEORGE: So, thank you. That is obviously
18	an excellent question and an obvious question.
19	So Erin Chamberlain, her background by trade,
20	she is a marketer. That is one of the reasons why I
21	wanted her over horse racing as well. We are spending an
22	awful lot of time and I don't think it is worth any of
23	our time, all of us here, to be talking so much about
24	something that perpetually loses money.
25	So the other thing that happened, as a result

of the meeting that we had two weeks ago, Erin and I 1 2 immediately reached out to our corporate marketing team, 3 as well as our Lake Charles marketing team with some 4 immediate improvements that we can start doing. 5 Also, we have best practices from around the 6 country, things that we have done in Pennsylvania, things 7 that we have done in Ohio. Things that we do in 8 Massachusetts that we think can breathe new life into 9 getting new people there. 10 I also appreciate Vice Chair McNabb, your observation about partnering with the right charities and 11 12 having the right affiliates. And having people that are 13 mutually aligned on driving people and admissions and 14 customers into the properties. So that is something we 15 are completely aligned on. 16 And then, I really must thank all of you. 17 Because the biggest thing that we can do, would be to increase the purse size. And through your actions in 18 19 prior years, that is helping provide a better product on the track. So that is what we are all committed to as 20 well. 21 22 CHAIRMAN PATE: Great. Thank you very much. 23 MR. GEORGE: Yes. 24 COMMISSIONER McNABB: I just want to tease this 25 out a little bit further. For the last recent years, ON THE RECORD REPORTING (512) 450-0342

Retama has kind of withered down to 27-some-odd days of 1 2 Quarter horse racing in the heat of the summer. You know, 3 it is critical to the Quarter horse industry in this 4 state, and all of their marketing plans. But you hold a 5 Class 1 license. 6 MR. GEORGE: Yes. 7 COMMISSIONER McNABB: Class 1 gives you certain 8 privileges and, you know, restrictions on anybody else 9 having any competition. And from the horseman's 10 perspective -- and being a veterinarian, I am all about the horses. Having three Class 1 tracks who are very 11 deliberately spaced around the state --12 13 MR. GEORGE: Right. 14 COMMISSIONER McNABB: -- to me, implies that 15 given the larger horse industry, we can't expect all 16 tracks to be open at all times for official works and all. 17 I got that. But having Retama 21 days doing Quarter horses 18 19 and that is it, but we have a statewide industry. What 20 are you looking at? Are thoroughbreds on your horizon? Ι 21 would really like to see, for a Class 1 track --22 MR. GEORGE: Yes. 23 COMMISSIONER McNABB: Granted, it is hot in San 24 Antonio. I got that. 25 MR. GEORGE: It is. ON THE RECORD REPORTING (512) 450-0342

COMMISSIONER McNABB: But in the wintertime, it 1 2 is pretty nice, you know. Thoroughbreds running up in 3 Kentucky at Turfway Park would probably much rather run in 4 San Antonio. 5 MR. GEORGE: I would think so. 6 COMMISSIONER McNABB: I would think so. I'm 7 interested in just what your plans are. Because really, 8 what I would like to see is when we can get to where we 9 have somewhat of a circuit. 10 But that also builds the industry. If people know that at any given time, there either is a Class 1 11 track with the quality surface and that whole experience 12 13 for training horses, that they can haul to and train. Or 14 it's a meet, and things can move around, then that makes a 15 healthier industry for Texas. 16 It also makes Texas a much more attractive 17 place for some of our larger operations that, you know, send a string to Texas and let them base here. But having 18 19 a Class 1 track that withers down to 21 racing days maybe 20 in the summertime in July in Texas is pretty sad. MR. GEORGE: I know --21 22 COMMISSIONER McNABB: It leaves those 23 Thoroughbred horses, really. And it puts a lot of undue 24 pressure on the other two tracks instead of having that 25 circuit. So I am interested in what you all see near and ON THE RECORD REPORTING

1 long term on that.

2	MR. GEORGE: I couldn't agree more. And thank
3	you for that observation. And Executive Director Cook,
4	myself, and others that were at the meeting two weeks ago
5	kind of started to talk about the way we could start
6	expanding this.
7	But it starts with a better product. At a
8	track that needed repairs, again, we've been attacking
9	that in the last two weeks. But we'll also talk more
10	about that with Bryan and Erin.
11	So thank you all again.
12	CHAIRMAN PATE: Thank you.
13	MR. PETTIGREW: Good morning, I am Bryan
14	Pettigrew. This is Erin Chamberlain. And we're going to
15	discuss the ability to conduct live racing a lot of
16	what you were just talking about.
17	We have got a facility that was 30 years old
18	when Penn came in. And then you go through the pandemic
19	and ice storms. And it is a lot to keep up with for a
20	30-year-old facility, like any of us.
21	Things happen. And you keep putting band-aids
22	on it. And sooner or later, you have got some problems.
23	And so one thing that we have seen is, we have got about
24	60 full-time employees there that are trying to catch up
25	over 30 years of issues.

And so that is the one nice thing that Penn is 1 2 able to do is bring in outside resources. We have got --3 this week we have got a team of engineers that are there checking what our state and local electrical contractors 4 5 had already reviewed. We have got our own engineers, 6 outside engineers coming in to make sure that the facility 7 is safe for the fans, for the horsemen and the customers. 8 9 And as well, next week, we have a crew that is 10 coming in from Louisiana just to help our operations team get caught up on changing light bulbs and ceiling tiles 11 and some of those things. 12 So there is a true commitment, not only the 13 14 capital that you see on the screen that has been invested 15 this year for new generators and food and beverage 16 equipment, but also some of the things that we are putting 17 in for safety and repairs on the track. We brought in new -- we brought in an outside 18 19 racing services testing laboratory that told us that the track needed to be -- had to have more cushion in it. And 20 so we brought in about 500 tons of sand. This was before 21 22 the week started. 23 I think everybody is seeing the results of 24 that. We have got horsemen that are saying, you know, 25 this is the best racing surface in 20 years at Retama ON THE RECORD REPORTING (512) 450-0342

Park. So we are proud of those little steps that we are
 taking.

3 We also just hosted the richest race in Retama 4 Park this past week, or two weeks ago with the Texas 5 Quarter Horse Association's sale futurity, so we are 6 making those little steps, marketing a little bit this 7 year. And I say a little bit, because the facility needs 8 to be updated and maintained. We don't want to stress the 9 facility this year. 10 So we are doing -- we did one promotion last week, very successful. We are doing two this week. And 11 12 we are building on those. Also trying to make sure our staff is capable of running these promotions and bringing 13 14 in new team members in the future. 15 CHAIRMAN PATE: I just want to say, Bryan, we 16 recognize the effort you all put in here recently. It has 17 been substantial, and we really do appreciate it. Thank you. We also -- along 18 MR. PETTIGREW: 19 the lines of, you know, the ability to construct and 20 maintain the track, we are in weekly, daily communications with Executive Director Cook and the staff. 21 22 We do daily measurements of the track, the 23 track's surface, the depth, and also the moisture in the 24 track. We do that. That is not something we have ever 25 done before. But that's something we are working on ON THE RECORD REPORTING

1 implementing this year.

2	And we submit that on a daily basis, and then a
3	weekly report. And that also goes to the Racing Surfaces
4	Testing Laboratories, which is a national database that
5	compares Retama Park to the other tracks in our region and
6	nationally.
7	In addition to those daily reports, we brought
8	in Jake Weitzel and Jose Coronado, who I must say Jose,
9	if you are not familiar with him, is the track
10	superintendent at Sam Houston Race Park, which is
11	nationally recognized as one of the safest tracks. And
12	today is his 30-year anniversary at working at Sam Houston
13	Race Park. So we are going to honor him tonight.
14	He doesn't know. And hopefully, he is not
15	watching this at Retama Park.
16	But we brought in Jake from Penn National. We
17	brought in Jose from Sam Houston. And they are both
18	onsite overseeing the daily track operations.
19	That is about all I have.
20	MS. CHAMBERLIN: The next slide. So, as we've
21	been talking about I think this kind of summarizes a
22	lot of what we have been talking about, our commitment to
23	Retama Park.
24	So \$2 million are planned for infrastructure
25	review and improvements, as we've been talking through.

HVAC system is sorely needed. Make sure that that is 1 2 running. So that is underway right now. 3 We are working through that. And as Bryan 4 talked about, we have a complete electrical review 5 underway right now. Bryan and I will be heading out to 6 the track after this to go check on the progress with 7 that, and check in with the team, and see what results we 8 are getting from there. 9 And you know, we have also just been walking 10 the property and making sure that it is presenting in a way that we are proud of. I think to your question, Judge 11 12 Pate, a lot of what we are seeing are things that we want to enhance because it is the right thing to do. And it 13 14 makes us proud to operate Retama Park. 15 And so as we walk around, there is any number 16 of customer-facing things that are either safety-related, 17 as we talked about with Executive Director Cook, or are just -- you know, they are not up to par with today's 18 19 standards in terms of what our customers have come to 20 expect. And so Bryan has been leading the efforts with 21 22 the team there to pull those things together, understand 23 what our customers are asking for, and what we need to do 24 to bring ourselves more in line with, say, what we are 25 doing at Sam Houston and make sure that we are presenting

1 the best foot forward where we do get folks to come to 2 Retama Park, because that is something that we are really 3 focused on.

And so one of the reasons, also, that Bryan was hired is because he is a very innovative and creative marketer as well. And so he has already started. What he didn't talk about was his Digging for Diamonds promotion that was this weekend, a very popular dollar beer night; you know, just some things to try and attract some new folks back to the facility.

But we do know that we have a lot of work to 11 do. And so our real plan is to really focus a lot of 12 13 efforts on cleaning up the property, ensuring that we are 14 safe, it is presenting very well, and then work in this 15 off season to really put together a strong marketing 16 program that we can tap into, and that we can launch for 17 We have a lot of good learnings next year's race theme. from what we have done already this season and some other 18 19 things that we have done around the country.

So as Tom mentioned, we have any number of racetracks -- 11 racetracks. And so we have some great prototypes to follow, where we -- you know, in our Meadows property outside of Pittsburgh for example, we draw 18,000 people over a course of a weekend for a food truck festival.

Those are the types of things, that once we 1 2 have the facility in order and the team in order that we 3 need them to be, we need to be doing at Retama Park to make sure that we are reintroducing the property back to the local community.

6 MR. PETTIGREW: One last comment is we are 7 using our management team. Sam Houston and Retama are 8 going back and forth, not only in the racing operations, 9 but for example, we have three new employees at Sam 10 Houston that have just been hired on, and they are coming over to Retama to see the racing this week. See the 11 promotions, event operations. 12

So they are not just going into January at Sam 13 14 Houston and never have seen a race live, or interacted 15 with horsemen in promotions. And so we are doing a lot of 16 that where we are taking our staff back and forth between 17 the two properties and working together with both teams.

19 MS. CHAMBERLIN: And one final comment. And 20 you know, obviously, improving the facility, improving the marketing are high priorities. But as we talked about 21 22 with Executive Director Cook at our meeting a few weeks 23 ago, I think underpinning all of this is really the 24 people.

And so the culture at Retama has an opportunity

1 to really improve greatly. And this is something Bryan 2 and I spent a lot of time talking about. And that is, you 3 know, a large part of why Bryan was hired. 4 He is based here in Texas. He will be onsite 5 regularly. We have made some leadership changes. There 6 are more opportunities for us to continue to strengthen 7 our team there. 8 And so, underneath it all, what we really want 9 to do is restore a culture of pride at Retama Park. And 10 we are starting that by, you know, building up the facility, building up the marketing plan. PETTIGREW: So we've been in touch with the 24 City of Selma, and we have also been in touch with the 25 hospital organization.

1	Right now, as you know, there is an Air Force
2	base nearby. The jets come by every day. We have a
3	no-fly-zone over Retama Park for the jets. But we plan to
4	work with them.
5	The helipad at the newly proposed hospital is
6	on the opposite side, so we are planning to work with them
7	on when we are racing, which directions to come in, what
8	their flight patterns will be.
9	COMMISSIONER McNABB: That helicopter low level
10	could be quite a Kodak moment.

7	investment of time just to visually look at equine
8	ambulances, track services, and all that weekly, and make
9	sure that everything is good, and nothing has changed.

11	And it is the same thing I did when I got in my

3. Texas Bred Incentive Program Receipts. The amounts appropriated above in Strategy D.1.1, Texas Bred Incentive Program, from the Texas-bred Incentive Fund No. 327 are estimated amounts set aside by the Texas Racing Act pursuant to Occupations Code, Sections 2028.101, 2028.103, 2028.105, 2028.154, and 2028.202 for the Texas Bred Incentive Program. Any

additional revenue set aside by the Texas Racing Act pursuant to Occupations Code, Sections 2028.101, 2028.103, 2028.105, 2028.154, and 2028.202 for the Texas Bred Incentive Program (estimated to be \$0) is appropriated to the Racing Commission in Strategy D.1.1, Texas Bred Incentive Program, in each fiscal year of the 2024-25 biennium.

None of the funds appropriated above for Texas Bred Incentive Program Awards may be expended for payments to a member serving on the commission. The Racing Commission shall take all necessary steps to ensure compliance with this provision.

4. Criminal History Checks and Background Checks.

- a. Funds appropriated above in Strategy A.1.2, Criminal History and Background Check, from GR Dedicated Texas Racing Commission Account No. 597 (estimated to be \$90,000 in fiscal year 2024 and \$90,000 in fiscal year 2025) are for the purpose of reimbursing the Department of Public Safety (DPS), Federal Bureau of Investigation (FBI), and/or any other entity authorized to conduct criminal history background checks for costs incurred in conducting criminal history checks or background checks on individuals seeking to transfer ownership interest in an existing racetrack license and on Racing Commission license applicants and renewals. Any additional revenue received from occupational and business license fees to cover the costs of criminal history checks or background checks (estimated to be \$0) is appropriated to Strategy A.1.2, Criminal History and Background Check, for the purpose of reimbursing the DPS, FBI, and/or any other entity authorized to conduct criminal history background checks.
- b. Before May 31, 2024, the Racing Commission shall submit a report to the Legislative Budget Board, in a format prescribed by the Legislative Budget Board, that details the amount collected and expended on criminal history checks and background checks to date and the amount the agency is projecting to collect and expend on criminal history checks and background checks for the remainder of the 2024-25 biennium.
- c. Any appropriation authority identified in subsection (a) of this rider not used for criminal history checks or background checks shall be lapsed by the Racing Commission.
- **5.** Witness Fees. From the appropriations made above, the Texas Racing Commission may pay the witness fees and travel expenses of out-of-state witnesses, subject to the advance, written approval of the Executive Director, for the law violation under investigation.
- **6. Recruitment and Retention Payments.** In accordance with Article IX, Section 3.06, of this Act, and with the approval of the Executive Director, the Racing Commission may pay an individual a recruitment or retention bonus as provided by Government Code, Section 659.262.
- 7. Moving Expenses. Notwithstanding any other provision of this Act, and with the approval of the Executive Director, the Racing Commission may use appropriated funds to pay the reasonable, necessary, and resulting costs of moving the household goods and effects of an employee of the Racing Commission who is transferred from one designated field office or headquarters to another so long as the Racing Commission determines that the best interests of the State will be served by such transfer.
- **8.** Commissioner Travel. Notwithstanding any other provision of this Act, the Racing Commission may not expend more than \$5,000 each fiscal year for payment or reimbursement for expenses related to the travel of the seven appointed members of the Texas Racing Commission.
- **9. State Contribution to Group Insurance for Retired Employees of the Racing Commission.** Notwithstanding the provisions of Article IX, Section 6.08, subsection (a), of this Act, the state contribution to group health insurance coverage for retired employees of the Racing Commission shall be paid from the General Revenue Fund.

This INTERAGENCY CONTRACT is made and entered into by and between the Texas Racing Commission (hereinafter referred to as TXRC), a Texas state agency with its principal office located at 1801 N. Congress Ave., Ste. 7.600, Austin, Texas 78701, and the Texas A&M Veterinary Medical Diagnostic Laboratory (hereinafter referred to as TVMDL), part of a state institution of higher education with its principal office located at 483 Agronomy Rd, College Station, TX 77843, acting by and through its authorized representative(s), pursuant to authority granted in TEX. GOV'T CODE, Chapter 771, §771.003 *et seq.*

I. PURPOSE

1.1 Pursuant to TEX. OCC. CODE Chapter 2034, § 2034.002, the Drug Testing Laboratory of TVMDL is to provide drug testing services on race animals for TXRC. The purpose of this INTERAGENCY CONTRACT is to delineate and specify the responsibilities and obligations of the parties in administering TXRC's race animal drug testing program.

II. DEFINITIONS

2.1 Definitions include the following:

- a. Association A person or entity holding a pari-mutuel racetrack license under the Texas Racing Act to conduct pari-mutuel wagering and/or horse or greyhound racing issued by the Texas Racing Commission.
- b. Authorized individual(s) Person(s) entitled to access to laboratory grounds based upon tier and access level(s).
- c. ELISA Enzyme-linked immunosorbent assay ("immunoassay").
- d. Executive Director Texas Racing Commission Executive Director or designee.
- e. GC/MS Gas Chromatography-Mass Spectrometry.
- f. ICP/MS Inductively Coupled Plasma Mass Spectrometry.
- g. IC-MS Ion Chromatography-Mass Spectrometry.
- h. LC-MS/MS Liquid Chromatography-Tandem Mass Spectrometry.
- i. LC-HRAMS Liquid Chromatography-High-Resolution Accurate Mass Spectrometry.
- j. LIMS Laboratory Information Management System. Electronic software program that stores results and releases case reports for TVMDL testing.
- k. MU Measurement Uncertainty.
- 1. Specimen Bodily substance, such as hair, blood, urine, saliva, or other bodily tissues collected for analysis from a horse or greyhound in a manner prescribed by the TXRC. Specimen sample may also include, but not limited to, substances contained in vials, loaded syringes, or other similar containers.

III. DESCRIPTION OF SERVICES

3.1 Duties of TVMDL: TVMDL agrees:

1. To provide sufficient security to control access to the TVMDL Drug Testing Lab or to areas where records and samples are stored including security measures such as extra access required in LIMS system, security permissions for backup instrument data, and locked laboratory doors.

2. To ensure only authorized persons handle samples or have access to TVMDL processes. There are two tiers of access for TVMDL employees.

- a. There are four types of access for authorized individuals. Tier 1 authorized individuals perform the testing; includes Access A authorized individuals requiring fingerprinting, background check and annual conflict of interest statement. Tier 2 authorized individuals support testing; includes Access B, C, and D authorized individuals requiring an annual conflict of interest statement.
- b. Access A: TVMDL employees who are trained to handle samples and perform testing in the laboratory (restricted to only TVMDL drug testing staff).
- c. Access B: TVMDL employees who have unescorted access to laboratory space. Examples include, but are not limited to, TVMDL drug testing laboratory staff, TVMDL senior agency executives, TVMDL quality assurance staff, and TAMUS IT support.
- d. Access C: TVMDL employees and LIMS vendor staff who have access to case information in LIMS (racing results require an extra access in LIMS so not all TVMDL employees fall in this category). Examples include, but are not limited to, TVMDL drug testing staff, TVMDL quality assurance staff, TVMDL employees who create accessions in LIMS, TVMDL employees that perform data entry in LIMS, TAMUS IT support, TVMDL finance staff, and LIMS vendor staff.
- e. Access D: TVMDL employees and TAMUS IT support staff who have access to backup instrumentation data generated during the testing (instrument printouts, control charts, etc...).

3. To inspect each shipment of all specimen samples on arrival at TVMDL for any evidence of possible tampering or compromise to the integrity of any specimen sample. Any evidence of tampering or compromise of specimen sample integrity shall be properly recorded and reported to the Executive Director in writing.

4. To use chain-of-custody procedures to maintain integrity, control, and accountability of specimen samples during all testing stages from specimen sample receipt to storage and final disposition.

5. To accession all specimen samples from Associations to the TXRC account.

6. To provide secured storage conditions to maintain specimen sample integrity while specimen samples for testing and split specimen samples are in the possession, custody, and control of TVMDL.

7. To maintain and follow approved quality control Standard Operating Procedures within the oversight of the TVMDL Quality Management System.

8. To provide analyses for alleged performance-enhancing drugs in submitted contraband samples (e.g., vials, loaded syringes, tubes of paste) by TVMDL methods including, but not limited to, LC-MS/MS, GC/MS, LC-HRAMS, or ELISA as requested by TXRC.

9. To provide specimen sample testing and split specimen sample testing, upon trainer's request, for the presence of prohibited substances and controlled therapeutic medications on equine urine specimen samples as follows:

a. Instrumental analysis (e.g., LC-MS/MS, GC/MS, LC-HRAMS, ICP-MS and IC-MS) on each equine urine specimen sample.

b.Specific gravity determination on each equine urine specimen sample with an accompanying serum furosemide concentration in excess of 100 ng/mL.

c. Each specimen sample with the presence of a therapeutic medication, at levels as published by TXRC, that exceed the maximum permissible concentration level shall be reported by TVMDL to TXRC as a positive result with the quantitative level and MU of the therapeutic medication.

d.Upon request by TXRC, specimen samples shall be tested by TVMDL for arsenic. Testing for arsenic shall be performed using ICP/MS, and the regulatory threshold maximum permissible level for arsenic is published in TXRC Permissible Therapeutic Substances List.

10. To provide testing for the presence of prohibited substances and controlled therapeutic medications on equine blood samples as follows:

a. Furosemide LC/MS screening on each equine serum sample to ensure compliance with TXRC's Bleeders and Furosemide Program. Evidence of non-compliance will be documented and reported to the TXRC. TVMDL will report as positive each specimen sample in which the concentration of furosemide exceeds 100 ng/mL and a urine specific gravity of less than 1.010. TVMDL will issue a report for each specimen sample in which the concentration of furosemide and a urine specific gravity of 1.010-1.012, or when no urine sample was submitted for testing. TVMDL will issue a report for each specimen sample in which the equine received furosemide treatment, but furosemide was not detected in the specimen sample. TVMDL will issue a report for each specimen sample in which the equine did not receive furosemide treatment, but furosemide was detected in the sample.

b.Test for total carbon dioxide on specimen samples of equine blood as requested by TXRC. Each specimen sample exceeding the maximum permissible level as published by TXRC shall be reported as positive to TXRC including the quantitative level. Alternatively, TVMDL may recommend another qualified laboratory conduct testing for total carbon dioxide.

c. Instrumental analysis by either LC-MS/MS, GC/MS, LC-HRAMS, ICP-MS, IC-MS on each equine blood sample. Additionally, each equine blood sample will be extracted and screened independently by instrumental analysis for the presence of dimethyl sulfoxide (DMSO). Pooling of no more than 4 samples is permissible.

d.Each specimen sample with the presence of a controlled therapeutic medication, as published by TXRC, that exceeds the corresponding maximum permissible concentration level shall be reported as positive to TXRC with the quantitative level and MU of the

medication.

e. Upon request by TXRC, samples shall be tested for cobalt in addition to or in lieu of the substances identified in Sections 9.a through 9.e. Testing for cobalt shall be performed using ICP/MS, and the regulatory threshold level for this element is as published in TXRC Therapeutic Substance List of the Endogenous, Dietary, or Environmental Substances Schedule (25 ppb in blood plasma or serum).

11. To perform testing for prohibited substance(s) including either a full comprehensive test panel or specified testing for beta-agonist drugs in equine hair samples by instrumental analysis as required or requested by TXRC.

12. To perform testing for the presence of prohibited substance(s) in canine urine samples. Testing shall be by instrumental analysis, LC-MS/MS, LC-HRAMS, ELISA, on each canine urine sample, with an emphasis on drugs classified as Category I or II in the published TXRC Medication Classification.

13. To perform confirmatory analysis on specimen samples whether equine or canine when a suspicious finding is identified in initial screening. At least one definitive analytical technique should be employed for the confirmatory analysis (e.g., mass spectrometry).

14. To perform tests as required by the Thoroughbred Owners and Breeders Association (TOBA) for substances in specimen samples from equine that participate in graded stakes races and listed stakes races at the \$75,000 purse level or above.

15. To expedite tests as requested for quarter horse trials with a goal of reporting test results to TXRC within five calendar days of receiving samples.

16. To screen blood samples labeled as "Vet Work" by LC-MS/MS or LC-HRAMS for non-steroidal anti-inflammatory drugs (NSAIDs), corticosteroids, or other drugs as requested by TXRC. Results for Vet Work samples will be reported by TVMDL to TXRC electronically within 120 hours of the specimen sample receipt by TVMDL.

17. To screen biological samples including, but not limited to, fresh tissue (e.g., muscle, liver and kidney, eye) collected as post-mortem tissue sampling in necropsy procedure(s) by instrumental analysis. Turnaround time depends upon the extent of confirmatory testing when the initial screening of a sample is deemed suspect but will not exceed ten business days. These samples results will be reported by TVMDL to TXRC electronically.

18. To perform other testing as requested by TXRC with prior approval by utilizing the most effective state-of-the-art or appropriate technology or platform testing methods.

19. To store all tested specimen samples and split specimen samples in secured conditions ensuring the specimens integrity before either disposal of or release to a third party (for various purposes). The minimum retention period for a negative specimen sample is five (5) calendar days after reporting to TXRC. The minimum retention period for a positive specimen sample is one (1) year after reporting to TXRC or until all legal proceedings concerning the sample conclude whichever is longer. The minimum retention period for all records is two years or until all legal proceedings concerning the specimen sample conclude whichever is longer.

20. To report negative test result(s) to TXRC within 120 hours from sample receipt, if possible. TVMDL will report positive test result(s) to TXRC within three weeks of TVMDL's receipt of specimen samples. On request by TXRC, TVMDL shall make available to TXRC a copy of the analytical case fileresults of any test conducted.

21. To provide qualified professional personnel to testify in an administrative hearing or other legal proceeding involving a test performed. TVMDL agrees to participate and assist with pretrial matters including, but not limited to, interrogatories and depositions.

22. To notify TXRC in writing at least thirty (30) days before implementing any change in analytical procedures which alters the detection sensitivity for any substance classified as Category Ill, IV, or V in the TXRC Medication Classification.

23. To participate in industry-recognized quality assurance program(s).

24. To refrain from disclosing any information relating to a specimen sample to any person other than specifically designated by TXRC to receive the information.

25. To maintain qualified Tier 1 and Tier 2 TVMDL staff with no financial interest in racehorses, racing greyhounds, a racetrack, or with any conflict of interest within the racing industry. All TVMDL laboratory personnel must be employees of the Texas A&M Veterinary Medical Diagnostic Laboratory, a member of the Texas A&M University System, and subject to the rules and policies of the A&M System as promulgated by the Board of Regents of the A&M System or the TVMDL Director.

26. To consent to background investigation for all Tier 1 TVMDL staff involved in the TXRC drug testing program under this agreement including, but not limited to, fingerprinting conducted by the Texas Department of Public Safety on behalf of TXRC.

27. To allow access by TXRC to all TVMDL records of drug testing services performed pursuant to this agreement.

28. To issue an electronic report to TXRC for all samples tested through this agreement.

29. To invoice TXRC for all samples tested through this agreement. TVMDL will make reasonable efforts to collect payment from TXRC after thirty (30) days from presentment to TXRC and will notify the Executive Director of any charges that are unpaid thirty (30) days after invoicing.

3.2 TXRC Duties. TXRC agrees:

1. To fund and directly provide all necessary supplies to Associations for the collection and shipment of specimen samples to TVMDL including, but not limited to, sample cards, sample jars, blood tubes, seals, labels, vacutainer sleeves, collection needles, and shipping containers.

2. To supervise the specimen sample collection site at each Association to ensure the site has the necessary personnel, supplies, equipment, facilities, and supervision to provide for the identification of animals and humans in the chain of custody and to collect, identify, secure, store, and ship each specimen sample to TVMDL.

3. To submit specimen samples from approximately 9,500 race animals per year. TXRC will make every effort to sample two (2) equine specimen samples per horse race and 0.9 canine specimen samples per greyhound race for testing at TVMDL. If the number of racing performances changes during the calendar year, the number of specimens may be adjusted accordingly. The TXRC Executive Director will notify the TVMDL Director as soon as practicable of changes in the number of racing performances. If the number of equine specimen samples, canine specimen samples, and/or racing performances decreases by more than 10% during the calendar year, TVMDL reserves the right to adjust test **fees** and agrees to notify the TXRC Executive Director at least thirty (30) days before any fee adjustments are made in writing.

4. To require each Association to deliver all samples to TVMDL in a secure manner ensuring specimen sample integrity in accordance with a TVMDL-approved delivery schedule at the Association's expense.

5. To apprise and update TVMDL in a timely manner of all drugs on the Medication Classification and Therapeutic Substance Lists and all changes in medication rules, policies, and procedures.

6. To promptly and completely submit payment for samples tested pursuant to this agreement to TVMDL. Payment is expected within thirty (30) days of the monthly invoice date.

IV. COST OF SERVICES

1. Except as otherwise provided in Section IV of this agreement, TVMDL agrees to charge, and TXRC approves, a per-specimen charge of \$150.00 for each blood and urine equine specimen sample tested [#1031, Drug Screen - Racing Equine Basic (LC/MS)].

2. TVMDL agrees to charge and TXRC approves, a charge of \$50.00 for each canine specimen sample tested pursuant to Article III, Sections 10 and *11[#1030, Drug Screen-Racing Canine (LC/MS)]*.

3. TVMDL agrees to charge and TXRC approves, an \$8.00 accession fee for each race day from each racetrack to receive samples, enter test requests, and data [#PROCESS01, Accession Fee].

4. For total carbon dioxide tests conducted by TVMDL, TVMDL agrees to charge, and TXRC approves, a per-sample charge of \$28.50, unless TVMDL recommends a different laboratory conduct the testing for total carbon dioxide in which case the charge shall be separately determined.

5. For tests conducted pursuant to Article III, Sections 8.d. (arsenic) and 9.e. (cobalt), TVMDL agrees to charge, and TXRC approves, a per-sample charge of \$23.00 [#1006, Arsenic (ICP/MS), #1015 Cobalt (ICP/MS)].

6. For tests conducted pursuant to Article III, Section 10, TVMDL agrees to charge, and TXRC approves, a per-sample hair specimen charge of \$145.00 for beta-agonist drug screening [#1021, Drug Screen-Beta Agonists in Hair or Feathers (LC/MS)].

7. For tests conducted pursuant to Article III, Section 13 (TOBA tests), TVMDL agrees to charge, and TXRC approves, a per-sample charge of \$250.00 for each blood and each urine specimen sample respectively *[#1033, Drug Screen-Racing Equine Comprehensive (LC/MS)]*. TVMDL agrees to charge, and TXRC approves, the hair specimen sample charges in Item 6 above, if necessary.

8. For tests conducted pursuant to Article III, Section 15 (vet work/medical clearance}, TVMDL agrees to charge, and TXRC approves, a per-sample charge of \$90.00 [#1034, Drug Screen – Racing Equine Medical Clearance (LC/MS)].

9. For ocular fluid tests conducted pursuant to Article III, Section 16, TVMDL agrees to charge, and TXRC approves, a per-sample charge of \$60.00 [#1032, Drug Screen – Racing Equine Breakdown (LC/MS)].

10. For fresh tissue, muscle, liver, and kidney organ tests conducted pursuant to Article III, Section 16, TVMDL agrees to charge, and TXRC approves, a per-sample charge of \$110.00 [#1544, Drug Screen – Unknowns (LC/MS)].

11. For necropsy racing mortality tests conducted, TVMDL agrees to charge, and TXRC approves, a charge of \$190.00 [#1350, Necropsy-Racing Mortality].

12. For tests conducted pursuant to Article III, Section 17 (other testing as requested), TVMDL and TXRC will mutually agree on the per-sample charge depending on the methodology and platform employed for testing.

13. Upon request by TXRC, TVMDL agrees to charge and TXRC approves, a per-sample charge of \$88.00 for each serum or urine specimen sample tested for beta-agonists [#1023, Drug Screen – Beta Agonists in Serum/Urine/Feed (LC/MS)].

14. Upon request by TXRC, TVMDL agrees to charge, and TXRC approves, a per-sample charge of \$86.25 for each serum or urine specimen sample tested for corticosteroids [#1024, Drug Screen – Corticosteroids (LC/MS)].

15. Upon request by TXR.C, TVMDL agrees to charge, and TXRC approves, a per-sample charge of \$80.00 for each contraband sample including each vial, loaded syringe, and paste tube [#1018, Drug Identification-Medications (LC/MS)].

16. Upon request by TXRC, TVMDL agrees to charge, and TXRC approves, a charge of \$250.00 per sample for comprehensive racing equine testing [#1033, Drug Screen – Racing Equine Comprehensive (LC/MS)].

17. Upon request by TXRC and trainer, TVMDL agrees to charge and TXRC approves, a charge of \$25.50 for each split sample referred to package and ship a split sample forwarded to another approved laboratory for testing [#REFER03, Referral Lab - Forwarding Fee].

18. For storage of specimen samples, split samples, and discarding of samples beyond retention periods pursuant to Article III, Sections 1, 4 and 18, TVMDL agrees to charge, and TXRC approves, a flat annual charge of \$1,000 [#ADDL22, Sample Storage].

19. TVMDL agrees to charge and TXRC approves, a charge of \$108 per literature packet requested for use at a TXRC hearing *[#PROCESS11, Literature Packet]*.

20. Pursuant to TEX. OCC. CODE § 2034.003, the Associations are responsible for payment of these charges. TVMDL will invoice TXRC, and TXRC agrees to pay TVMDL for the testing charges on behalf of each racetrack Association. Thereafter, TXRC will invoice the respective racetracks for payment of their portion of TVMDL costs incurred.

Venue of any court action brought directly or indirectly by reason of this INTERAGENCY CONTRACT shall be in Travis County, Texas. This INTERAGENCY CONTRACT is made and is to be performed in Travis County, Texas and is governed by the laws of the State of Texas.

VIII. ENTIRE AGREEMENT

This INTERAGENCY CONTRACT, including any Exhibits, embodies the final and entire agreement of the parties hereto, superseding all oral or written, previous and/or contemporaneous, agreements between the parties and relating to matters in this INTERAGENCY CONTRACT. No other agreements, oral or otherwise, regarding the matters of this INTERAGENCY CONTRACT shall be deemed to exist or to bind the parties hereto unless same be in writing, dated subsequent to the date herein and executed by the parties.

IX. LEGAL AUTHORITY

The signers of this INTERAGENCY CONTRACT represent, warrant, and guarantee that the signor has full legal authority to execute this INTERAGENCY CONTRACT and to bind the respective party to all the terms, conditions, provisions, and obligations contained in this agreement.

X. SEVERABILITY

If any clause or provision of this INTERAGENCY CONTRACT is held invalid, illegal, or unenforceable under present or future federal, state, or local laws, then it is the intention of the parties that such invalidity, illegality, or unenforceability does not affect any other clause or provision and that the remainder of this INTERAGENCY CONTRACT shall be construed as if such invalid, illegal, or unenforceable provision was never contained in this agreement. It is also the intention of the parties that in lieu of each provision of this INTERAGENCY CONTRACT that is determined to be invalid, illegal, or unenforceable that there be added as part of the INTERAGENCY CONTRACT, a provision similar in terms to such invalid, illegal, or unenforceable provision, as may be possible, to make the provision legal and enforceable.

XI. EXECUTION

The Parties agree to use due diligence in the exercise of their responsibilities as outlined in this INTERAGENCY CONTRACT. The term of this INTERAGENCY CONTRACT is from the date of Commission approval or September 1, 2023, whichever is later, through August 31, 2024. To ensure the continuity of the drug testing program in pari-mutuel racing, all terms of this INTERAGENCY CONTRACT continue in effect until a new INTERAGENCY CONTRACT is executed with the understanding that TVMDL reserves the right to adjust fees prior to execution of the new INTERAGENCY CONTRACT and will notify the TXRC Executive Director in writing at least 30 days in advance of fee adjustments. If either Party determines that events have changed and significantly affected a material term of the INTERAGENCY CONTRACT including, but not limited to, the closing of a racetrack or a significant increase in the cost of drug testing or testing supplies, the Parties agree to renegotiate the terms of this INTERAGENCY CONTRACT prior to the date of termination.

For the faithful performance of this agreement, this agreement is executed by the undersigned persons in their capacities described below. This agreement takes effect on the date of approval by the Commissioners of the Texas Racing Commission or September 1, 2023, whichever is later.

AGREEMENT BETWEEN TEXAS ARABIAN BREEDERS ASSOCIATION, TEXAS PAINT HORSE BREEDERS ASSOCIATION, TEXAS QUARTER HORSE ASSOCIATION AND **TEXAS THOROUGHBRED ASSOCIATION**

Discussion and possible action to extend the existing 2023 allocation of funds for the Texas-bred incentive program as provided under 16 TAC §321.505(b) to align with the expiration of the Horse Industry Escrow Account agreement expiration date.

Pursuant to Section 321.505(b) of the Texas Rules of Racing, the Commission shall determine the percentages by which Texas Bred Incentive Program funds generated from simulcasting are divided among the various breeds of horses.

In an effort to achieve a fair and equitable share of revenue available to the Texas state-bred incentive program for owners and breeders, the following Agreement is made by and between Texas Arabian Breeders Association (TABA), Texas Paint Horse Breeders Association (TPHBA), Texas Quarter Horse Association (TQHA) and Texas Thoroughbred Association (TTA).

As previously allocated for calendar years 2011 - 2023, it is agreed that ATB incentive funds generated from simulcasting shall be allocated to the respective breeds as follows:

At Class 1 tracks (Lone Star Park, Retama Park and Sam Houston Race Park), the funds shall be allocated 66.67% to Thoroughbreds and 33.33% to Quarter Horses after a 2% deduction off the top for Arabians and a 1% deduction off the top for Paint Horses.

At Gillespie County Fair Grounds, the funds shall be allocated 33.33% to Thoroughbreds and 66.67% to Quarter Horses after a 2% deduction off the top for Arabians and a 1% deduction off the top for Paint Horses.

In order to be aligned with other breed split agreements, this agreement shall be in effect for calendar year 2024.

The foregoing is acknowledged and agreed to on this 7 day of August, 2023.

We, the undersigned representatives of Texas licensed pari-mutuel racetracks, the Texas Quarter Horse Association, the Texas Horsemen's Association, the Texas Thoroughbred Horsemen's Association, the Texas Thoroughbred Association, the Texas Paint Horse Breeders' Association and the Texas Arabian Breeders' Association unanimously agree to the allocation of \$17,500,000 per year in purse funds that became available specifically via the successful passage of House Bill 2463 during the 2019 session of the Texas Legislature; as well as the continued allocation of the purse money generated for horses via cross-species simulcasting. This letter serves as a follow-up and update to my letter of October 21, 2022, concerning the five-year review of your Greyhound racetrack license by the Texas Racing Commission in accordance with the Texas Racing Act, TEX. OCC. CODE §§2025.104 and 2025.106, and the Texas Rules of Racing, 16 TEX. ADMIN. CODE §§309.51 and 309.53.

As you may be aware, the 88th Texas Legislature declined to approve the contingency funding the agency sought for Greyhound racing regulation in the *General Appropriations Act for the 2024-25 Biennium*. As a result, effective October 1, 2023, the Texas Racing Commission must determine the future of your greyhound license.

The Texas Racing Commission intends to consider the status of your license on August 16, 2023, during a public meeting, in Austin, and will be guided by the following:

Texas Racing Act, Sec. 2025.104(e): "An active license is effective until the license is designated as an inactive license or is surrendered, suspended, or revoked under this subtitle."

Texas Rules of Racing, Sec. 309.51(c): "Subsequent Designation. After the initial racetrack designation is made under subsection (a) of this section, the Commission may change the designation of the racetrack license at any time if the facts that supported the current designation change."

Please provide me with the name and contact information for the designated representative(s) at your earliest convenience, and I will coordinate with and provide this person or persons with additional information related to the meeting and testimonial expectations. The Commission may or may not act on the racetrack license during this meeting but will complete its review and decide about the status of the license no later than December 31, 2023.

The designated representative(s) should be prepared to discuss the status of the license and actions taken during the past five years to justify renewal as an active greyhound race track. During the meeting, the Commission may renew the current greyhound active license, inactivate its' license, or refer the license to the State Office of Administrative Hearings for licensure revocation for failing to meet the requirements of the *Texas Racing Act* or *Texas Rules of Racing*.

with the rule's requirements, please submit to the Commission the following information in a single, comprehensive communication on or before 5:00 p.m. (CDT), Friday, July 28, 2023:

(1) copies of the association's current management, concession, and totalisator contracts;

(2) a copy of the association's current security plan;

(3) for each person owning an interest of at least five percent of the association and for each officer, director, or management committee member who is not currently licensed as an Association Officer or Director by the Commission: a. a completed background information form and written authorization for the Commission and the Department of Public Safety to conduct any investigation deemed necessary; and

b. a set of fingerprints on a form prescribed by the Department of Public Safety, or if the person already has a set of fingerprints classified and on file with the Department of Public Safety, authorization to resubmit those fingerprints to the Federal Bureau of Investigation and the Department of Public Safety for investigation; and

(4) a review fee of \$5,000.

Additionally, include with this report a copy of all management, totalizator, and concessionaire contracts with documentation of Commission approval under Sec. 309.162, and proof of adequate liability insurance for the racetrack under Sec. 309.153.

Upon receiving this information, we will prepare a report to the Commission based on information provided by the association, the results of any inspections or investigations conducted as part of the review, and any other information that is relevant to the association's ownership or management, including any letters of community support or concern provided to the Commission. Notwithstanding the above items, the Commission may require additional information or documentation to determine whether Valley Race Park should remain a greyhound racetrack. I appreciate your continued engagement as Commission Staff works through this process and the agency continues to address the past concerns of the Sunset Advisory Commission and the Texas Legislature.

Please be advised that the Texas Racing Commission will be conducting a review of the above greyhound racetrack in the year 2023 under the Texas Racing Act, THN. OCC. CODE §§2025.104 and 2025.106, and the Texas Rules of Racing, 16 THX. ADMIN. CODE §§ 309.51 and 309.53.

The Texas Rules of Racing §309.51 define an active racetrack as either:

- 1. "Active operating" which means the license holder conducted live racing events at the racetrack during the previous state fiscal year and has been granted future live race dates; or
- "Active other" which means the license holder has applied for and received pending live race dates under §303.41 (allocation of race dates) and undertaken actions demonstrating good faith efforts to conduct live racing including, but not limited to,
 - (A) presently conducting pre-opening simulcasting;

(B) demonstrated that simulcast and live racing is imminent by the license holder including: (i) securing sufficient financial commitments to fund construction of the racetrack facility; (ii) security the real property of the designated racetrack location for which the license was granted; (iii) entering into contracts for construction of the simulcasting and racetrack facilities; (iv) security Commission approval of the racetrack construction plans; (v) security permits and utilities necessary for the facilities; (vi) beginning and sustaining construction of both the simulcast and live racing facilities; and (vii) providing to the Commission a construction and operations management schedule that reflects imminent simulcasting and that the facilities will be ready to conduct live racing by the beginning of the approved live race dates; or

(C) voluntarily providing a \$400,000 bond on or before September 1 to ensure the license holder conducts pre-opening simulcasting and completes the pending allocated live race dates.

After the initial racetrack designation is made under the Rules of Racing §309.51(a), the Commission may change the designation of the racetrack license at any time if the facts that supported the current designation change. The designation change could also include the designation of "inactive" defined simply as not meeting the requirements for the racetrack license to be designated as "active-operating" or "active-other". The

Commission can also refer an inactive license designation to the State Office of Administrative Hearings without sufficient evidence of any factors relevant to the consideration of an inactive designation under the Rules of Racing 309.52(a), (e), and (h)(2).

In performing the review, the Commission requires one designated point of contact who is authorized to make decisions regarding the status of the racetrack license including the person's name, address, telephone number and email address. We may also require as part of the review process any information that would be required with an original license application under Chapter 2025 of the Racing Act in addition to the documentation required in the Rules of Racing §§309.52 and 309.53(b).

In preparation for the 2023 reviews before the Commission, I will meet with the representatives of each racetrack license in person, either in Austin or at each current or proposed location. It is critical that we work together to clearly define the status of each racetrack license to facilitate an appropriate staff recommendation to the Commission. An agency representative will also conduct on-site visits in preparation for the Commission's review anticipated to be no earlier than the regularly scheduled Commission meeting in August 2023. I look forward to spending time with your designated primary point of contact and other stakeholders as we prepare for the racetrack license review.

(B) demonstrated that simulcast and live racing is imminent by the license holder including: (i) securing sufficient financial commitments to fund construction of the racetrack facility; (ii) security the real property of the designated racetrack location for which the license was granted; (iii) entering into contracts for construction of the simulcasting and racetrack facilities; (iv) security Commission approval of the racetrack construction plans; (v) security permits and utilities necessary for the facilities; (vi) beginning and sustaining construction of both the simulcast and live racing facilities; and (vii) providing to the Commission a construction and operations management schedule that reflects imminent simulcasting and that the facilities will be ready to conduct live racing by the beginning of the approved live race dates; or

(C) voluntarily providing a \$400,000 bond on or before September 1 to ensure the license holder conducts pre-opening simulcasting and completes the pending allocated live race dates.

After the initial racetrack designation is made under the Rules of Racing §309.51(a), the Commission may change the designation of the racetrack license at any time if the facts that supported the current designation change. The designation change could also include the designation of "inactive" defined simply as not meeting the requirements for the racetrack license to be designated as "active-operating" or "active-other". The

Commission can also refer an inactive license designation to the State Office of Administrative Hearings without sufficient evidence of any factors relevant to the consideration of an inactive designation under the Rules of Racing §309.52(a), (e), and (h)(2).

In performing the review, the Commission requires one designated point of contact who is authorized to make decisions regarding the status of the racetrack license including the person's name, address, telephone number and email address. We may also require as part of the review process any information that would be required with an original license application under Chapter 2025 of the Racing Act in addition to the documentation required in the Rules of Racing §\$309.52 and 309.53(b).

In preparation for the 2023 reviews before the Commission, I will meet with the representatives of each racetrack license in person, either in Austin or at each current or proposed location. It is critical that we work together to clearly define the status of each racetrack license to facilitate an appropriate staff recommendation to the Commission. An agency representative will also conduct on-site visits in preparation for the Commission's review anticipated to be no earlier than the regularly scheduled Commission meeting in August 2023. I look forward to spending time with your designated primary point of contact and other stakeholders as we prepare for the racetrack license review.




Retama Park Ownership and Operational Structure
